

In short, clear chapters he shows how the bank operates, who funds it, and what it sets out to promote. The Bank's main purpose is to grant loans to all the newly independent states of the developing world, to help them on their journey to recovery after colonial occupation. In reality, the conditions imposed on these states — including enforced privatisation of all public services, and enforced neo-liberal rules on trade — mean that the Bank has become the new colonial authority in everything but name.
