

Last week, the International Monetary Fund finally announced the cancellation of all the debts Haiti owes to the Fund. The cancellation will wipe out US \$268 million – by far the largest remaining component of Haiti's debt. The cancellation will be given via the newly established Post-Catastrophe Debt Relief Trust Fund, which was set up for this purpose and which can now be accessed by other highly indebted, low income countries hit by disasters.
