

EDITO

On Thursday, 20th August, Alexis Tsipras announced his resignation and called for new elections to take place on 20th September. This action was predicted since the third memorandum and the opposition of 43 Syriza parliamentarians (32 voting against and 11 “abstentions”.) The following day 25 deputies of the Syriza left platform and other members of the Greek left announced the formation of the Popular Unity party to regroup around the

victorious NON of the 5th July referendum. While the debt [audit report by 30 international and Greek experts clearly reveals that almost the entire Greek debt is illegitimate, illegal, odious and unbearable](#), Alexis Tsipras chose another path rather than disobeying the creditors.

[A rousing speech, on the role of illegitimate debt in the Greek crisis, was given by Zoe Konstantopoulou's](#) during the Fourth World Conference of Speakers of Parliament on 2nd September in New York. She clearly states that the policies imposed by the creditors of Greece, over the last five years, "have resulted to severe violations of human rights, especially social rights, fundamental freedoms and the very rule of law" [...] "On the 25th January 2015, only seven months ago the Greek people, through general elections, gave a clear and unequivocal mandate, to Government and to Parliament, to do away with these homicidal policies".

Let us not forget the enormous responsibility of the creditors and especially the ECB which acted like a vulture fund against Greece and the hopes put in a government genuinely working for the public interests. [Olivier Bonfond and Renaud Vivien reveal in their article](#) how this institution – supposed to be independent – has exceeded its mandate and has acted more than once in an illegal manner.

In the meantime, Ukraine otherwise politically destabilised is devastated by debts that have reached excruciating levels. Even deals claiming to restructure Ukrainian debts fall far short of required debt reduction. The articles: 'New food for the vultures? Lack of state insolvency regime undermines Ukraine debt deal' and 'Campaigners call for UK government to enforce Ukraine debt deal' reveal the enormity of this problem and the culpability of Western nations in aggravating the crisis.

SPECIAL GREECE



On the 13 July 2015, In spite of the enormous 62% victory of the NO/OXI to austerity in the Greek 5 July referendum, the creditors imposed an unacceptable agreement on the Greek Prime Minister. Then, during the night of the 15 to 16 July the Greek parliament ratified this new memorandum with the support of the right wing parties. The Syriza party being split. The intermediate report of the Greek Debt Truth Commission presented on the 17 and 18 June 2015 established that the debt demanded from Greece is almost entirely, illegitimate, Illegal and odious. It is also unsupportable. Until now the findings of the report have not been used by the Greek Government. In the months and years ahead the Greek debt will be at the centre of European issues. The combat for debt justice for the Greek people is far from over. International solidarity with the resistance of the Greek people must be strengthened. (...)
