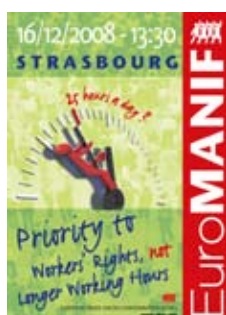

Dear readers,

The economic crisis is now a reality. It is already having highly visible social consequences with many job cuts and bankruptcies.

An effective European response is needed to cope with this crisis.

The European Commission has just announced a useful although modest (compared the USA) coordinated stimulus plan aimed at keeping the crisis from turning into a long and deep recession. We are convinced that social dialogue has a crucial role to play in this context of rekindling the economy. That is why the European social partners have asked the current EU Presidency to organise a special tripartite social summit to be held on the eve of the forthcoming European summit of 11 and 12 December.

Trade union organisations must seize this opportunity and bring all their influence to bear to help redirect global economic governance so that what we are experiencing today will never occur again.

European trade unions will demonstrate in Strasbourg on 16 December against any weakening of the Working Time Directive. That day marks the eve of the European Parliament's vote in plenary and we intend to influence the vote through this European trade union mobilisation. Other issues that are important for us will also be on the agenda of this session of Parliament, including the European Works Councils and the Climate and Energy Change Package.

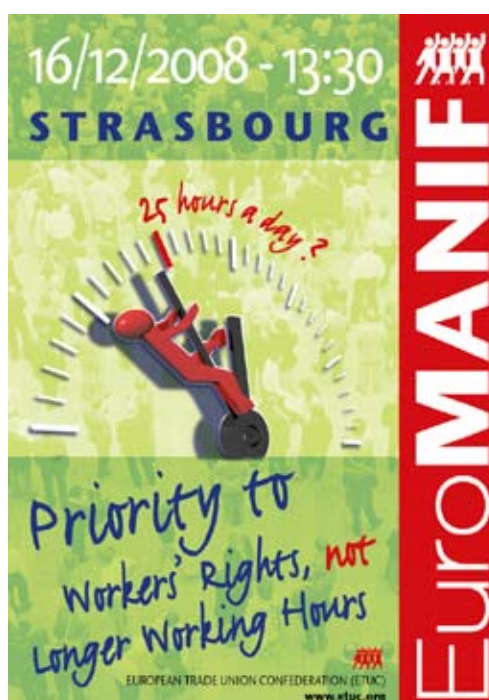
Euro-demonstration – Strasbourg – 16 December 2008

ETUC is organising a Euro-demonstration in Strasbourg, on 16 December 2008, on the eve of the European Parliament’s vote on the revision of the Working Time Directive.

This vote is fundamental for European workers, because if the proposals made by the EU Council of Ministers in June are maintained, it will weaken the directive currently in force, by allowing a proliferation of opt-outs and on-call work. This will restrict workers’ rights and it represents a blow to Social Europe.

[The European trade union movement](#) is opposed to the proposals made by the [Council of Ministers](#) and is asking the European Parliament to adopt amendments that ensure:

- protection against long working hours that



are a threat to the health and safety of all workers, whatever their level of responsibility

- the end of all abuse in the form of excessively long working hours (opt-out)
- recognition of on-call time (attendance time) at the workplace as working time
- the role of collective bargaining, and information and consultation of workers in the organisation of working time
- workers’ right to adapt their working hours in terms of their needs

If the Parliament does not secure an absolute majority for its position ([Report of Alejandro Cercas, Member of the European Parliament](#)), the Council’s proposals will have force of law. This has to be avoided at all costs and the commitment of all of us is fundamental !

Economic crisis: the European Commission's recovery plan has to be implemented rapidly

26/11/2008 – ETUC welcomed the [European Commission's Economic Recovery Plan](#), in which action to boost the demand side of the economy is central. For the European trade union movement, it is fundamental that this plan is implemented rapidly, in particular the 170 billion package that the Member States are supposed to provide. ETUC believes that social dialogue and social partners' input have a key role to play to avoid social recession and downwards wage spirals. In this connection, ETUC, together with employers' organisations, ETUC calls for an exceptional Tripartite Social Summit to take place before the next European Summit on 11 and 12 December.

Working time: ETUC welcomes the vote in the EP Committee on Employment and Social Affairs

05/11/2008 – ETUC welcomed the fact that the European Parliament Committee on Employment and Social Affairs adopted the [Cercas report on Working Time Directive](#). This report disavows the decision taken by the Employment, Social Policy, Health and Consumer Affairs Council (EPSCO) last June, which was a disastrous move for European workers. ETUC calls on the European Parliament to adopt a firm position with regard to the Commission and Council at the vote in plenary on 17 December. The European trade union movement will organise a Euro-demonstration on 16 December in Strasbourg to ask the European Parliament to reject the Council's decision and to confirm its position adopted at first reading.

Financial crisis: ETUC writes to Presidents Sarkozy and Barroso

06/11/2008 – On the eve of the extraordinary European Council in Brussels, and of the G-20 meeting in Washington, on 7 and 15 November respectively, ETUC wrote a letter to Presidents Nicolas Sarkozy and José Manuel Barroso, asking them to do all that is necessary to face the challenge of putting the financial sector back at the service of the real economy. For ETUC, the casino capitalism model, based on the principle 'borrow to speculate', has to end. For the European trade union movement, it is fundamental to deeply and structurally reform the World financial system, to not let the real economy down and to ensure workers get a fair deal. At the same time, ETUC asked G-20 members to take fully into account the [International trade union Declaration](#), issued at the Washington summit.

Barcelona process: the role of the social dialogue

19/11/2008 – ETUC and its Euromed Trade Union Forum participated in the [first Euro-Mediterranean ministerial conference on employment and work in Marrakech, Morocco, on 9–10 November 2008](#). **ETUC welcomed the adoption of a framework of action which provides for the creation of a Euromed social dialogue forum** : *'For the first time since the process of Barcelona has started, there is scope for a sustainable and coherent social policy. ETUC and its Euromed Trade Union Forum will do their best to use the "Social dialogue forum" as a driving factor'*, declared Maria Helena André, ETUC Deputy General Secretary.

Press conference on working time

06/11/2008 – The day after the European Parliament Employment and Social Affairs Committee voted on the Cercas report, the ETUC Press and Communication Department organised a press conference on the Working Time Directive. John

Monks, Alejandro Cercas, Member of the European Parliament, and Pepe Galvez, Secretary for trade union action (Federation of Public Services of Comisiones Obreras), explained the stakes and the risks of increasing working hours

if the revision proposed by the Council is adopted. During the press conference, ETUC announced the organisation of a Euro-demonstration in Strasbourg on 16 December, on the eve of the second reading vote.

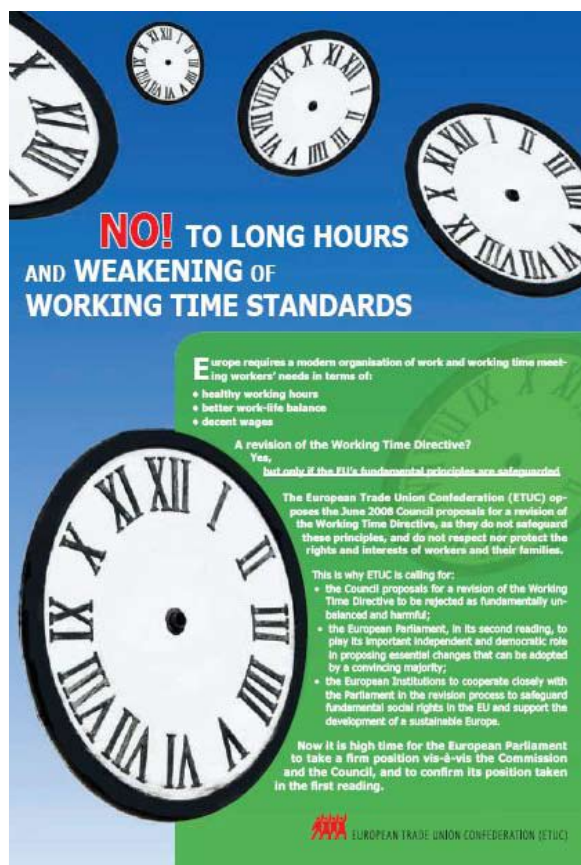
