**Together for a better future:
No to austerity! Yes to jobs for young people!**

Ahead of the European Summit scheduled for 14 and 15 March, the European Trade Union is organising a **European Trade Union action on 14 March against austerity and for jobs for young people**. For the ETUC, austerity is not working and an urgent change of direction is needed. One of the action's priorities will be to focus on young people who are paying the heaviest price for the crisis and austerity. In the context of this mobilisation, the ETUC will organise a **European trade union rally** in cooperation with the Belgian trade unions (FGTB/ABVV, CSC/ACV, CGSLB/ACLVB) on 14 March in the EU district in Brussels.

The Employment, Social Policy, Health and Consumer Affairs Council (EPSCO) adopted the Youth Guarantee yesterday. The Youth Guarantee also offers some financial support, even if insufficient to cover all needs.
