#### Concrete changes to save Europe now

A ETUC delegation took part in the Tripartite Social Summit for Growth and Employment ahead of the European Council. The ETUC reiterated its call for an effective social dimension to the EU and for stopping the attacks on workers' rights. According to the ETUC, deregulation risks undermining citizens' support for the European project. Moreover, the ETUC presented the [Joint Declaration by the European Social Partners on the involvement of the Social Partners in the European Economic Governance](#). The European Social partners sent also a [joint letter to the President of the European Council](#) asking for the settlement of an investment plan to stimulate growth and employment creation.



#### Empty words on social Europe, strong words to support deregulation

A “broader understanding” of social imbalances and injustices is what the EU Council considers as being the social dimension of the EMU. This is miles away from Social Europe as the ETUC understands it. For the ETUC, Council conclusions offer no perspective to re-direct economic policies towards more equality, less poverty, and long-term investment for sustainable growth and good jobs. On the eve of the European Summit, the Executive Committee of the ETUC adopted a [statement calling for an ambitious European investment programme](#) with a target of investing an additional 2% EU GDP per year over the next decade
