50,000 workers from all over Europe gathered in Brussels to demonstrate against austerity and for investment, quality jobs, equality

On April the 4th, 50,000 workers from 21 European countries took to the streets of Brussels to express their dissatisfaction with the economic situation and the economic policies being pursued. The crisis of unemployment and poverty has yet to be tackled and trade unions are fighting for new policies to get Europe



back to work. “Austerity is not working. Austerity has caused a mounting social and economic crisis: over 26 million Europeans are jobless, 10 million more than in 2008. This is why we demonstrate and demand a New Path for Europe, based on investments, quality jobs and equality” said [Bernadette Ségal at the Euro-demonstration](#).

Barroso and MEPs fail to sort out the rights of "Posted" workers

Commenting on the outcome of the vote on the Enforcement of the Posted Workers Directive – in which MEPs rejected all [amendments designed to strengthen enforcement](#) - Bernadette Ségal said “Mr Barroso has failed to do what he promised which is to resolve the shortcomings in interpretation and implementation of the Posted Workers Directive. It is deeply frustrating and disappointing. A strengthening of the Directive itself is now more urgent than ever”.

‘Intra-Corporate Transfer’ Directive

The ETUC is disappointed with the outcome of the vote in the European Parliament on the Intra-Corporate Transfer (ICT) Directive. While the ICT Directive proposes minimum equal pay and the same working hours and health and safety conditions as locally employed workers, [it does not prevent other important differences in costs and conditions](#). In particular, transferred workers would not be guaranteed the full working conditions and benefits of local workers agreed through national collective agreements and laws.

Spring Alliance calls on Europe’s leaders to put people and planet first



The [Spring Alliance](#) - bringing together European trade unions and environmental, social and development organisations launched its [spring alliance manifesto](#) “A better Europe now” which aims to present a positive vision of Europe that puts people and planet first. Through the manifesto, the Spring Alliance calls for a radical departure by the next European Commission and European Parliament from current policies which have not succeeded in solving the crisis and have led to citizens increasingly losing their trust in their political leaders and in the European project.

Company directive = tax and labour rules avoidance charter

The European Commission’s draft Directive on a ‘single member limited liability company’ is a charter for avoiding tax and national labour rules warns the ETUC. While the European Commission presents the Directive as a means of helping small business to trade across the single market, the ETUC points out that there is nothing

to stop large companies setting up single member subsidiaries to avoid tax and labour regulations.
