Social Europe united in reaction to ECJ ruling

After last week's ruling by the European Court of Justice on the Rüffert case, SOLIDAR responded with a media release calling on European decision-makers to reconsider the Posting of the Workers Directive issued by the European Commission in view of better assuring the enforcement of individual and collective labour rights and the possibility to pursue social policy objectives and the interest of society as a whole. Conny Reuter, Secretary General of SOLIDAR commented: "*It is not surprising then that many citizens question whether the Europe we are creating is a social Europe, with decent jobs or a haven for free-market ideologues which seek to undermine the fundamental principle of equal pay for equal work.*"

SOLIDAR's position, published in Euractiv, was among other similar concerns put forward by organisations, including the European Trade Union Confederation (ETUC) and the Socialist Group in the European Parliament, whose representative Martin Schulz MEP stated that: "*the freedom to provide services in other countries should not be at the expense of workers' wages and conditions. We cannot allow workers' social rights to be undermined.*"

Debating a project for a social Europe

The Socialist Group (PES) in the Committee of the Regions (CoR) organised a seminar on 8 April entitled 'New Social Europe' which constituted the Group's contribution to the PES Manifesto for the 2009 European elections. The event aimed to encourage a broad exchange of views on the major challenges for the PES political family in shaping a genuine Social Europe. SOLIDAR was invited to represent the European networks of social NGOs.

The SOLIDAR representative spoke on the question of social and demographic change putting forward the main issues of concern for social NGOs and some specific SOLIDAR positions. Concerning political action at EU level, SOLIDAR, as well as the Social Platform, urges policy makers in national governments and the European Parliament to overcome the constant blockage in the adoption of legislation in the social field, e.g. with regard to pending directives on parental leave and working time. Linked to questions of social and demographic change, we expect concrete advancement in the fields of equality between women and men, the fight against all forms of discrimination, the protection of workers in new forms of employment, access to employment for excluded groups, the integration of migrants and their access to rights throughout Europe and the issue of quality services of general interest for all. The PES Group's CoR seminar offered an excellent opportunity to voice these concerns in a phase of mobilisation and preparation of programmes for the European Parliamentary electoral campaign in 2009.

More transparency in the European institutions

On the 1 April the European Parliament (EP) adopted a report on lobbying transparency. The report calls for an obligatory registration system for the 10,000-15,000 lobbyists

common to the European Commission, European Parliament and the Council, as well as "full financial disclosure" of public affairs consultancies and law firms, covering their turnover, expenditures associated with lobbying and, in the case of NGOs and think tanks, their budget and sources of funding. The European Commission is not in favour of having an obligatory register, and for the moment is only considering a voluntary registration of lobbyists.

SOLIDAR supports an obligatory register for all lobbyists in all of the European institutions in order to enforce transparency in lobbyist activities in Brussels, in particular those of a business nature. SOLIDAR not only supports the recognition of NGOs defending a particular interest, but also for the acknowledgement of NGOs representing the general interest, related to the pursuit of a society building on fundamental rights, solidarity, equal opportunities and non-discrimination, social inclusions and social cohesion.

Rich countries not achieving aid commitments

In 2005, the world's rich countries pledged to allocate 0.7% of their Gross National Income to development assistance in order to implement the Millennium Development Goals (MDGs), which range from halving extreme poverty to providing universal primary education, all by the target date of 2015. Ahead of the G8 Development Ministers meeting this weekend, which comes at the halfway mark of the programme, the Organisation for Economic and Co-operation Development's (OECD) Development Assistance Committee has released final figures on official development assistance (ODA) in 2007. These figures show a fall of 8.4% in overall ODA which is mainly due to the phasing out of the debt relief programmes. The OECD concluded: "Overall, most donors are not on track to meet their stated commitments to scale up aid; they will need to make unprecedented increases to meet their 2010 targets."

Lessons learnt implementing SGIs and State Aid

SOLIDAR has documented an example of the application of community state aid rules in the field of social services of general interest involving our German member AWO, based on a recent decision taken by the European Commission's Directorate General for Competition. The AWO SANO case concerns a specific field of personal social services, a family vacation centre, and received a high level of attention from stakeholders in Germany over the last years. The decision is interesting with regard to several issues, such as 'entrustment', 'mandating' and 'public service obligations'. It also helps to understand under which conditions it could be possible to operate with a list of criteria to "prove" the social nature and general interest orientation of an activity. The decision also sheds light on the question of how fiscal advantages, enshrined in "public utility" regulations, can be taken into consideration when assessing the compatibility of public financial support to social service providers related to cost to build and maintain social infrastructures.
