Assistance to Burma

The United Nations (UN) estimates that over 100,000 people have been affected by the cyclone which devastated the Irrawaddy Delta region of Burma on Saturday. Despite the fact that there are a substantial number of people in desperate need of assistance, Burma's military junta is not allowing foreign aid workers to come into the country, instead preferring to distribute foreign aid donations themselves. The UN is putting increasing pressure on the Burmese military junta to speed up the issuing of visas for foreign aid workers. SOLIDAR members Volkshilfe Austria, Prosvil Italy, APHEDA Australia, NPA Norway, ASB Germany and Austria and SLA Switzerland are organising themselves to assist the people of Burma.

Shaping the future Social Agenda

Conny Reuter, Secretary General of SOLIDAR and President of the Social Platform, made an intervention at a conference organised on the 6 May by the European Commission to help develop the renewed Social Agenda. In his speech Conny asserted that *"The Social Agenda of the EU must propose concrete measures to tackle existing and prevent new poverty, exclusion and inequalities, especially affecting women and people living with disabilities."* He continued by saying that *"Should you be serious about bringing more solidarity in Europe, Mr Barroso, it is time to shift your priorities from the limited 'growth and jobs' vision to a social and sustainable development of Europe".*

The European Commission is to publish a package of documents linked to the EU Social Agenda which include a Communication on the review of the Open Method of Coordination (OMC), and directives on health services and on fighting discriminations of persons with disabilities. SOLIDAR considers this an important first step but supports the Social Platform in calling on the Presidents of the institutions "to make sure that the future social agenda includes a clear recommendation to broaden the scope of anti-discrimination legislation for all grounds and policies beyond Article 13". In particular that the Directive becomes horizontal, also covering not only discrimination in the work place but also access to goods and services.

EP Report on social inclusion

This Tuesday, the Employment Committee of the European Parliament (EP) discussed the first draft of the report "Promoting social inclusion and combating poverty, including child poverty, in the European Union", prepared by MEP Gabi Zimmer. SOLIDAR contributed to the drafting of the EP report by building on our reply to the consultation on active inclusion and meeting with the rapporteur and shadow-rapporteur of the PES.

The report underlines that the overarching aim of active inclusion policies must be to implement fundamental rights in order to enable people to live in dignity and participate in society as well as the labour market. It calls on the Commission to consider child poverty and social exclusion in a broader context of EU policy making including issues such as immigration, discrimination, gender equality and active inclusion. Labour market inclusion

for disadvantaged persons should also comprise personalised pathways to secure and stable, high-quality employment in accordance with people's needs and capacities. It finally highlights the importance of promoting integrated services that respond to the multi-dimensionality of poverty and social exclusion, e.g. the link between poverty and homelessness.

Update on Lisbon Treaty ratification

The Lisbon Treaty ratification process is on track with four more countries having approved the text in the last two weeks. Slovakia finally gave its green light to the Treaty on 10 April ending a dispute on a controversial media bill. On 23 April, Portugal, the country that hosted the signing of the Treaty of Lisbon, ratified it with an overwhelmingly parliamentary majority, while Denmark and Austria did the same the following day. This means that the Lisbon Treaty has now been adopted in 11 out of 27 countries.

Ireland is the only EU country where a referendum will be held (probably on 12 June). Recent events such as Prime Minister Bertie Ahern's resignation, the assault on Labour MEP Proinsias De Rossa and the polls showing that the majority of Irish voters seem to be still undecided on how they will vote make it hard to draft a scenario on the possible referendum outcome.

Transparency initiative

On Tuesday 8 May the European Parliament voted on the draft report on the Register for Lobbyists. This report calls for an obligatory registration system for the 10,000-15,000 lobbyists common to the European Commission, European Parliament and the Council as well as full financial disclosure.

The Civil Society Contact Group (CSCG) of which SOLIDAR is a member through the Social Platform, was disappointed as all the amendments they asked to vote for, were turned down by MEPs. This included benchmarking on financial disclosure, making public unethical lobbying practices, improving the transparency of EC advisory groups and improving the European Parliament own rules on transparency. Conny Reuter, Secretary General of SOLIDAR said that *"we are very disappointed with these results. We do not want confusion between economically interested lobby groups and civil society organisations who defend the general interest."* On a positive note, the draft report does already ask for a mandatory system, including lobbyists names, their clients and funders.

New Social Balkans

From 7-9 May, SOLIDAR in cooperation with its member the Olaf Palme International Center (OPIC) welcomed over 20 representatives from civil society organisations in the Western Balkans (from Bosnia-Herzegovina, Albania, Serbia, Macedonia and Kosovo) on a Study Visit to Brussels to learn more about accession to the European Union and to promote the social dimension of this process.

In Round Tables hosted by Goran Färm MEP and Jan Andersson MEP in the European Parliament, the delegation had fruitful discussion with MEPs on the Social and Employment Perspectives of European Enlargement, touching on the need for the European institutions to hold more education sessions in the Western Balkans with workers to inform them about the EU and its policies. The delegation also met the European Commission, International Trade Union Confederation (ITUC) and European Policy Centre to exchange on the importance of the social side of the enlargement process.

ISCOS Final Conference

The final project conference 'Transnational learning for Civil Society Organisations in New Member States' took place on the 29 April 2008 in Brussels gathering together over 30 representatives from the European institutions, International Trade Union Confederation (ITUC), project participants and coordinators. During the conference the main project results from each country were presented, possibilities for the future were looked into as well as presentations from other stakeholders for discussion. The aim of the project was to improve

the capacity of NGOs and trade unions in New Member States and increase political awareness on the labour conditions in developing countries within their own organisation as well as with other civil society organisations.
