Report Calling for Review of Posting Workers Directive to Secure Decent Working Conditions in Europe

Presented last week at the European Parliament's Employment Committee, MEP Jan Andersson's draft report on 'Challenges to collective agreements in the EU' is a clear and straightforward reaction to the December 2007 and April 2008 European Court of Justice (ECJ) rulings (Viking, Laval and Rüffert cases).

With its call for ensuring a *"necessary balance between the free movement of services and the right of workers"*, the report reaffirms the fundamental value of the principle of non-discrimination, that is to say equal pay for equal work, to avoid unfair competition on wages and on working conditions (which has already lead to xenophobic prejudices and behaviours) and in order to ensure that the Lisbon Treaty's objective of improving living and working conditions is fulfilled. Social implications of the Food crisis

After the high-level meetings of the Food and Agriculture Organisation held in Rome on 2-5 June, SOLIDAR is disappointed as yet another high level government conference has failed to tackle the real issues at hand by introducing an immediate change of policy. This emergency meeting was called to discuss the causes of the current "food crisis" and find solutions to what is proving to be an urgent humanitarian issue in many developing countries and an issue that pre-occupies the minds of more and more European citizens who are finding it hard to make ends meet as food prices rise whilst their incomes remain stagnant. Update from SOLIDAR's Sri Lanka Consortium

The humanitarian operations in conflict affected areas continue to be impeded by severe fuel shortages due to the strict government control of fuel and other material transportation into Liberation Tigers of Tamil Eelam (LTTE) controlled areas. One of the serious problems confronting the SOLIDAR Consortium is the delay in granting of work visas for staff particularly for those who have already been issued contracts by Norwegian People's Aid. Absence of visa permission for staff could endanger SOLIDAR's project activities in Sri Lanka.

The European Commission talks Active Inclusion

At the SOLIDAR Social Affairs Committee meeting which took place in Brussels on 3 June, guest speaker, Michele Calandrino, from the European Commission's DG Employment, talked to the participants about the Active Inclusion dossier; how the European Commission sees it, where they are with it and its link to Social Services of General Interest (SSGIs). Michele explained that the Commission has already had two consultations on this topic and is now in the process of elaborating common principles, working in rather a new way by involving Members States, the European Parliament, the European Economic and Social Committee (EESC) and the Committee of Regions (CoR) on the three strands of the active inclusion policy i.e. minimum income, labour market inclusion and access to quality services.
