RENEWED SOCIAL AGENDA: EUROPEAN PARLIAMENT TAKES A CLOSER LOOK

This Tuesday, the European Parliament organised a first debate around the Renewed Social Agenda adopted by the European Commission at the beginning of July. The package of 18 legislative and non-legislative initiatives around employment, social protection, health, migration and integration, and anti-discrimination was presented by Employment, Social Affairs and Equal Opportunities Commissioner Vladimir Spidla. Members of the European Parliament were divided in their reactions. In globally assessing the package, Harlem Desir, the Socialist Group's vice-president for social questions said that "*the social package is too little too late in the face of the precariousness and inequalities produced by the economic crisis that is hitting employees and numerous European citizens daily*". He also mentioned the insufficient response in view of the working poor. His homologue Gabi Zimmer from the GUE/NGL Group criticised a lack of progress concerning collective bargaining and social rights, and a vagueness as regards actions announced. [Read more...](#)

FRENCH EU PRESIDENCY PROGRAMME OF ACTION IN EMPLOYMENT AND SOCIAL POLICIES

With the Renewed Social Agenda being the overarching element, the programme is shaped around three axes: 1) flexicurity, mobility of the labour force, protection of workers rights including combating illegal labour practices, 2) solidarity (demographic change and intergenerational solidarity, social services of general interest, active inclusion) and 3) gender equality and the fight against discriminations.

The work programme builds on a report drafted by Bernard Brunhes on the future of social Europe after 2010. Read the report in [English](#), [French](#), [German](#).

The work programme was presented at the informal meeting of ministers for labour, employment, social affairs, health and consumer protection on 10 and 11 July in Chantilly. SOLIDAR MISSION: IMPORTANT FIRST STEP TOWARDS SOLIDAR STRATEGY IN MIDDLE EAST

This week the Chair of the SOLIDAR International Cooperation Committee Sergio Bassoli from member organisation Progetto Sviluppo, Secretary General Conny Reuter, and International Cooperation Coordinator Andrea Maksimovic went on a mission to Israel and Palestine.

During the three-day visit, the delegation had 16 meetings with key civil society and institutional actors, including NGOs, trade unions, labour support organisations, peace movement representatives and the European Commission.

The wide scope of the organisations that were met provides fertile ground for conceiving how SOLIDAR and its members can act together to enhance and support the important project and political work going on in the region.

NEGOTIATIONS ON AID REFORM STALL AS SOUTHERN GOVERNMENTS ARE BLOCKED BY DONORS

The CONCORD network, of which SOLIDAR is a member, has written a statement on the High Level Summit on Aid Effectiveness which took place in Accra, Ghana from 2-4 September.

"3 September - Negotiations over donor promises to reform aid are seeing Southern government's proposals blocked in closed door meetings to agree a forward looking agenda for action on aid effectiveness promises.

Over 1000 representatives from governments of the OECD (Organisation for Economic Cooperation and Development) and developing countries have gathered in Accra, Ghana, to report on their progress and agree a plan of action, but on day three of the conference, talks have stalled as the US, Japan and the World Bank block agreements on timetables for action". EDUCATION

The European Civic Forum, being held in La Rochelle, France from 4-6 September and supported by the European Commission and the French EU Presidency, is gathering together over 850 European associative actors for discussion on key issues such as mobility, dialogue and participation. The event aims to develop a more active and participative citizenship. Jean-Marc Roirant, President of the European Civic Forum and Chair of the SOLIDAR Board, stated, *"We aim for this event to reinforce the necessity of a civic and popular ownership of Europe. The debates during the event are mainly focused around the role and place of associations and NGOs in European civil dialogue which is essential in order to bring back a meaning to our engagement in Europe and to give citizens a renewed 'appetite' for Europe"*.

Conny Reuter, speaking as President of the Social Platform, said in his speech at the opening ceremony that *"associations are vital as they give citizens a voice. One of European social NGOs biggest concerns at the moment is the social dimension of European policies and how to encourage citizens' to engage in the future of Europe"*.
