DECENT WORK RECRUITMENT DAY

On 3 September, the Decent Work Decent Life Campaign held the Decent Work Recruitment Day at the European Parliament Plenary Session, asking Members of the European Parliament to reaffirm and reinforce their commitment to promote Decent Work for All. *"In the midst of the discussion on the European Commission's Social Package and with burning issues on the European agenda, such as the Working Time Directive and the equal pay for equal jobs principle, it is high time to ask our elected representatives to renew their commitments to make decent work a reality for all,"* said Conny Reuter, Secretary General of SOLIDAR. He continued *"Today, September 3rd, European people have entered the Parliament and asked their representatives to support the Call to Action for Decent Work, for a more Social Europe."*

Jan Andersson MEP and Rudi Delarue launched the day at which more than 100 MEPs visited the Decent Work Recruitment Desk to sign the Call to Action: [a list of signatories is available online](#)

'GLOBALISING DECENT WORK DECENT LIFE' PUBLIC DEBATE

- **15 September: Conference - Globalising Decent Work: from political will to implementation strategies** - hosted by Josep Borrell MEP - this event is co-organised by SOLIDAR and the Global Progressive Forum in the framework of the Decent Work Decent Life Campaign and the EU funded project jobs Jobs Jobs. The conference Globalising Decent Work is structured into three moderated panels: 1) The challenges for Decent Work in Europe; 2) Decent Work, MDGs, and Poverty Eradication; 3) Trade for Decent Work.
- **16 September: Round table - Chinese Investments in Africa and Latin America: what challenges for the Decent Work Agenda?**

China has announced increasing economic cooperation and aid pledges and may become Africa's largest trade partner by 2010. At the same time, its role as trade and development partner for Latin America's countries is also growing. Looking at China's presence in both Latin American and African key economic sectors, the round table will look at the following questions:

- o What impact has it on EU-Africa development cooperation strategies?
- o How this impacts EU-Latin America relations?

Following the Government's order to withdraw from the Vanni earlier this week, UN Agencies and International Non Governmental Organisations (INGOs) that were providing humanitarian assistance to Internally Displaced Peoples (IDPs) have begun to relocate their international staff, non residential national staff and most assets to the government-controlled Vavuniya District. EP REPORT ON THE PROMOTION OF SOCIAL INCLUSION AND COMBATING POVERTY VOTED

This Wednesday, the own-initiative report "Promoting social inclusion and combating poverty, including child poverty, in the European Union" was voted on by the European Parliament's Employment and Social Affairs Committee. SOLIDAR contributed to the draft report in discussing the main lines of the document with rapporteur Gabi Zimmer (GUE/NGL, Germany) which built on SOLIDAR's reply to the consultation on active inclusion. INSIGHT INTO IRISH NO VOTE ON EUROPEAN TREATY

Mid-June, Irish voters in a referendum rejected the New European Treaty or Lisbon Treaty. This week the Irish government published results of an enquiry it had launched to find out more about the reasons behind the vote. This research revealed that the biggest reason for voting NO was the lack of information and understanding citizens had about the 400-page document.
