### EUROPEAN COMMISSION SIGNS CALL TO ACTION FOR DECENT WORK

This week the European Commission has made an historic commitment to the Decent Work Decent Life campaign with the President of the European Commission, Manuel Barroso and European Commissioner and Vice President, Margot Wallström, lending their support to the campaign which is gathering momentum worldwide. Conny Reuter, Secretary General of SOLIDAR explains that ***"Decent Work is a social justice agenda which is important for trade unions but also for progressive civil society organisations and should be at the core of European internal and external policies in order for all people to be able to live in dignity. We know today that sound social policies are fundamental tools to ensure social cohesion and hence to foster economic growth as well as citizens' trust in EU policies."***

On the World Day for Decent Work on the 7 October, Margot Wallström, signed the Call to Action for Decent Work at an action carried in front of the European Council in Brussels. The day after, 8 October, a Decent Work delegation met Mr Barroso in his offices where he signed the Call, which has so far been supported by thousands of individuals and organisations in over 50 countries.

## SOCIAL AFFAIRS

### FIC AND SOLIDAR SEMINAR ON FLEXICURITY AND LABOUR MARKET INCLUSION

On 2 October, SOLIDAR, together with its Danish member FIC, organised a [seminar on flexicurity](#). The aim of this seminar was to discuss the issue of flexicurity and labour market reform, as well as making SOLIDAR better known in Denmark.

Conny Reuter, Secretary General of SOLIDAR, highlighted in his intervention that "***flexicurity is being presented by many as an all encompassing model and a cure-all solution, also for disadvantaged and vulnerable persons and groups.***" But he stressed that "***only with strong social policies, is flexibility possible, and not the other way around. Flexicurity is an interesting principle, but what is important is the final result. The key issue is how many people we bring back to the labour market with decent working and living conditions.***" [Read more...](#)

### RECOMMENDATION ON ACTIVE INCLUSION ADOPTED

On 3 October the European Commission published a Recommendation on Active Inclusion. It is based around the three key elements of the active inclusion concept: adequate income support, inclusive labour markets and access to quality services. For all three strands the Recommendation sets out common principles and guidelines that should support Member States when designing or revising their policies, in particular oriented towards people excluded from the labour market and fighting poverty and societal exclusion. The common principles set out by the Commission represent a voluntary framework for Member States. They will be formally discussed by national governments at the Employment and Social Affairs Council in December 2008 where conclusions on follow-up actions will be drawn. [Read more...](#)

### SOLIDAR POSITION ON COLLECTIVE AGREEMENTS AND THE POSTING OF WORKERS IN THE INTERNAL MARKET

Following the adoption of the Report 'Challenges to collective agreements' by the EP's Employment

and Social Affairs Committee on 22 September, SOLIDAR has issued a position to members of the European Parliament, the European Commission, trade unions, social NGOs and some national ministries of Employment and Social Affairs. The position refers to and takes up challenges and risks SOLIDAR has identified in four recent rulings against the Commission by the European Court of Justice (Laval, Viking, Rüffert, Luxembourg) on the Posting of Workers Directive.

SOLIDAR strongly supports the analysis and requests in the Report prepared by EP rapporteur Jan Andersson. SOLIDAR calls for the re-establishment of a real balance between fundamental rights recognised in the European Charter of Fundamental Rights and by Member States and the fundamental freedoms of the internal market. ### WORLD DAY FOR DECENT WORK ACTIONS: SOLIDAR MEMBERS' MOBILISATIONS

On 7 October several SOLIDAR members celebrated the World Day for Decent Work with a wide range of activities. Here are some examples of these mobilisations around Europe:

**Belgium: FOS and Solidarité Socialiste** were actively involved in the launch of a 2-year [campaign](#) which brings together Belgian Development NGOs and Trade Unions. 'Workers are not tools' is the

campaign's slogan.

**Lithuania: Lithuanian Labour Research Service** - together with the youth trade union centers - set up a 'decent work' trolley bus. Activists on the bus led a raising awareness action talking to the people waiting at bus stops about decent work and the importance of joining a union.

**Switzerland: Swiss Labour Assistance** led a [visual action](#) together with trade unions and the socialist party, asking public authorities to stop buying goods and furniture whose production conditions do not respect core labour standards (e.g. no forced labour, no child labour) and decent working conditions (e.g. fair working time).

**Laborers' Voice** also carried out [an action](#) for the World Day for Decent Work
