INTERNATIONAL COOPERATION

FINANCING FOR DEVELOPMENT

Next week at the General External Relations Affairs Council, EU governments will agree on a set of conclusions to take to the Doha Financing for Development Conference. SOLIDAR has been engaged in the process leading up to the conference through CONCORD's Working Group and we have contributed to the advocacy processes towards EU and UN institutions. There is now less than three weeks left and it is a crucial time for us to maximise pressure on governments in order to ensure an outcome document which reflects the severe need for solidarity with developing countries in this time of the food, fuel and financial crisis.

In particular we urge all member states to resist the temptation to water down their Overseas Development Assistance (ODA) commitments - we call on all Member States to support binding timetables in order to ensure the predictability of aid and fulfill the promises we have made. The financial crisis must not be used as an excuse to go back on ODA commitments. In addition, we urge Member States to support innovative sources of funds such as the Carbon Tax proposal in order to enable additional funding for climate change adaptation and to ensure there are strong commitments to ensuring that tax havens and other mechanisms for tax evasion that currently deprive developing country governments of billions of dollars they need to invest in public services and poverty alleviation.

For those who are in contact with their development cooperation ministries we hope you can reiterate these messages.

SOLIDAR will be present in Doha where we will organise in the framework of the Decent Work Decent Life alliance a parallel Civil Society Organisation event on 'Financing for Decent Work'.

A GOOD DAY FOR DECENT WORK IN EUROPE: EP ADOPTS CERCAS REPORT ON WORKING TIME DIRECTIVE

On Tuesday 4 November, with the adoption by the European Parliament Committee on Employment and Social Affairs of the Cercas report on the Working Time Directive, the European Parliament marked a good day for Decent Work in Europe.

The adoption of the report by a large majority (35 votes for, 13 against and 2 abstentions) makes clear the Parliament's disagreement with the decision taken by the Employment, Social Policy, Health and Consumer Affairs Council last June. According to the report, the maximum working time in the EU should be 48 hours per week (as foreseen by ILO Convention n. 1) and the possibility for a Member State to opt out should be removed within 3 years after the reformed directive enters into force.

The amendments proposed by the employment committee will be voted on in the plenary session in December. In the same week, the ETUC has called for a demonstration in Strasbourg (16 December) to ask that everybody in Europe is ensured a decent working time for a decent quality life.

SOCIAL AFFAIRS

EMPLOYMENT CREATION, RECRUITMENT, QUALIFICATIONS AND WORKING CONDITIONS IN SOCIAL SERVICES

SOLIDAR contributed to the 2nd Forum on social services of general interest held last week in Paris with a

[presentation](#) exploring patterns of recent employment growth in many European countries, benefiting women and people above 55 in particular, as well as presenting and illustrating a number of challenges such as recruitment, qualifications and working conditions (non-standard/irregular working hours, relatively low wage levels, gender pay gaps, staff shortages, an increasing number of fixed-term contracts, undeclared work and undocumented work carried out mainly by female migrants from Central and Eastern Europe.)

Social services of general interest (SSGIs) are a core element of social protection schemes. They contribute to the realisation of a range of objectives in the interest of our societies, such as a high level of employment, health protection, equality between men and women, and economic, social and territorial cohesion. They help in reducing poverty, social exclusion and various forms of discriminations and in enhancing the capacity of individuals to participate fully in society. ENCOURAGING PUBLIC AUTHORITIES TO MAKE BETTER USE OF SOCIAL CONSIDERATIONS WHEN BUYING GOODS AND SERVICES

In 2005 the EU's public procurement markets were worth more than one sixth of the EU's gross domestic product. This clearly underlines their economic importance, but also the need to shape them around social, ethical or environmental considerations and objectives. A study on the legal and policy framework for the inclusion of social criteria in call for tenders in selected Member States, including six case studies, has been recently published.

Yesterday the European Commission (DG Employment, Social Affairs and Equal Opportunities & Internal Market) organised a meeting to inform representatives from trade unions, employers' associations and civil society organisations about the main results of this study. During the seminar Commission staff sketched out the next steps in view of the elaboration of a Commission guide and asked for first comments. Interested parties are invited to make their comments and proposals by the end of this year, and the document should then be ready by late spring 2009. The guide will aim at providing more clarity on the applicable legal framework as to social considerations and at encouraging their usage when public authorities at national, regional or local level buy goods and services. This voluntary registry aims to provide information to citizens on general or specific interests that are influencing the decision-making process. Following the guidelines, SOLIDAR followed a higher standard of transparency than the current inconsistent and insufficient requirements of the register.
