### SOLIDAR ACTION PLAN FOR WORK IN PALESTINE/ISRAEL

Following the meeting of our International Cooperation Committee on 14 January 2009, members of SOLIDAR present elaborated the following elements underpinning our immediate and long term work in Palestine/Israel. This reference frame provides an orientation for the involvement of our members and guides the intervention of the SOLIDAR Secretariat.

It takes into account the need for urgent action in favour of a ceasefire, the intensification of international and European pressure on Israel for achieving it, as well as preparing for the post-conflict work which will not only need to respond to the humanitarian emergency, but also support those forces on both sides who engage in dialogue for peace and reconciliation. ### SOLIDAR CONTRIBUTION TO SOCIALLY-RESPONSIBLE PUBLIC PROCUREMENT GUIDE

This week SOLIDAR contributed to a consultation on the European Commission's Guide on socially-responsible public procurement (SRPP). SOLIDAR stresses that it is essential that a Guide like this exists, which will expand on the legal framework at European level and practical procedural issues for including social and ethical considerations in public procurement practices. As this will facilitate the implementation of policies supportive to the realisation of social and sustainable policies according to the shared values of the EU - including dignity, solidarity, justice, equal opportunities - and of the individual and collective rights as enshrined in the Charter of Fundamental Rights.

In the contribution SOLIDAR suggests points that it would like to see in the future Guide and backs up its suggestions with examples given by SOLIDAR member, Swiss Labour Assistance, from running a campaign on public procurement practices in Switzerland.

### CZECH EU COUNCIL PRESIDENCY PRIORITIES IN SOCIAL POLICY

After the prolific French Presidency, the Czech Prime Minister Topolánek presented on 6 January 2009 the priorities and the work programme of their EU Council Presidency. The key priorities of their Presidency are the three 'E's': Economy, Energy and Europe in the world, with the motto 'Europe without barriers'. Their priorities have however been criticised as not bringing anything new to the debate.

Fighting the economic crisis will be priority number one. The Czech strategy aims to remove all remaining barriers to the full application of all internal market freedoms. In this vein, the Czech Presidency aims to boost cross-border service provision by fully transposing the Directive on services in the internal market. In order to improve the EU's competitiveness, the Czech Presidency will emphasise the benefits of the full liberalisation of the movements of workers and aims to increase employment and labour market flexibility through the implementation of the common [flexicurity principles](#). Regarding social services, the Presidency will focus on their role as a tool for preventing social exclusion and for active inclusion in the labour market and society, as well as an area of growing employment opportunities.
