The SOLIDAR delegation led by Josef Weidenholzer, President, is present at the World Social Forum (WSF) which was opened on Wednesday by a march of several tens of thousands of participants calling for more global justice and the eradication of poverty. In terms of participation, the WSF is a huge success with more than 100,000 people participating from all continents, with a high presence of young people who want to see a fairer globalisation based on sustainable social and environmental development.

### CZECH PRESIDENCY: WHAT ARE THE SOCIAL PRIORITIES?

Based on a first assessment by SOLIDAR of the Czech Presidency's priorities and work programme for employment, social affairs and health, it appears that there is a lack of firm commitment to strengthen the social dimension of the EU. The social policy priorities set out, which are reflected in the upcoming conferences (see agenda below), are in three main areas: flexicurity and labour market reform, cross-border healthcare, patient rights and patient mobility in the internal market, and social services. ### CAMPAIGN FOR A MORE SOCIAL AND SUSTAINABLE EU LEADERSHIP

SOLIDAR is participating in the launch [event](#) of a 2009 campaign, Spring Alliance, organised by the European Trade Union Confederation (ETUC), the European Environmental Bureau (EEB) and Social Platform taking place on 29-30 January. This campaign will focus on influencing the policy priorities of the new European Commission and, even further, for the EU over the next decade, especially aiming at making social and sustainable development the ultimate goal of the new Social Agenda and the post-Lisbon Strategy.

As stated by John Hontelez, Secretary General of EEB and co-moderator of the first session, the ultimate goal of the alliance should be to make policy-makers aware that social fairness and equity are not a matter of political choice, but are imperative to future policy-making. ## INTERNATIONAL COOPERATION

### HUNGER STRIKE FOR ZIMBABWE

Africa's Heads of State will meet this Sunday in Addis Ababa where they will be greeted by a crowd of hunger strikers, calling for justice and democracy in Zimbabwe. Kumi Naidoo, a South African activist who will address the African Union summit about Zimbabwe's crisis, is urging activists worldwide to join in with his hunger strike this Sunday ([see video](#)).

As the political stalemate between Mugabe and Tsvangirai's parties continues, Zimbabwe is lurching towards economic collapse, with cholera, hyperinflation, hunger, and Mugabe's brutality only getting worse. SOLIDAR urges African leaders to lend their support to Morgan Tsvangirai, SOLIDAR Silver Rose award winner in 2001, and stands in solidarity with the freely-elected party of Zimbabwe, the Movement for Democratic Change.

### WESTERN BALKANS: PROMOTING SOCIAL INCLUSION AND DECENT WORK

Last week SOLIDAR provided feedback to DG Enlargement on the 'Civil Society Facility - Partnerships Program'. SOLIDAR's contribution focused on two elements: 1) that Decent Work should become the basis for promoting cooperation between social-economic partners around themes such as social rights, social protection and gender equality, and 2) that special attention is needed for partnerships between civil society organisations that promote the social inclusion of vulnerable groups.
