

PERSPECTIVES FOR SOCIAL EUROPE FACING THE CRISIS

With the crisis, governments across Europe are concerned with implementing short- and mid-term measures to stabilise the economy and to maintain jobs (or at least minimise job losses). Social NGOs and trade unions fear that we are going to lose out of sight any policies aiming to create quality and decent jobs. At the same time the sustainability of our social protection systems seem also at risk. How do we fund tax reductions, often suggested as a panacea these days, while raising the necessary social expenditure to address the negative consequences of the crisis?

In response to these questions, the Global Progressive Forum event, taking place in the European Parliament in Brussels on 2-3 April, will gather together over 1000 leaders from all continents representing progressive civil society organisations, political parties and trade unions to debate and come up with alternative solutions to the crisis, as well as a long-term strategy for a fresh approach to the current neo-liberal and conservative policies. SOLIDAR is involved in the preparation of the event and we invite all SOLIDAR members and other civil society organisations to take part in the making of this agenda for a New Global Deal!

BASE WORKING TIME DIRECTIVE ON DECENT WORK

With the Working Time Directive being debated by the European Council and the European Parliament today, SOLIDAR sent out a [statement](#) reiterating its full support of the European Parliament's pro-decent work stance, voted for at the Plenary session on 15 December 2008.

"Amidst the economic crisis, protecting quality jobs, creating more and better jobs, guaranteeing social rights at work, extending social protection and promoting social dialogue are imperative for a sustainable future of Europe; the Working Time Directive should not become an obstacle to that" underlines Conny Reuter, Secretary General of SOLIDAR.

SPRING ALLIANCE AND WSF FOLLOW-UP

Following SOLIDAR's participation in the launch event of the 2009 Spring Alliance campaign organised by the Social Platform, European Environmental Bureau and the European Trade Union Confederation on 29-30 January ([more info](#)), SOLIDAR members are invited to get involved in the follow-up Working Groups. The aim of the follow-up Working Groups is to develop suggestions to be included in a manifesto to be presented to the newly elected European Parliament and European Commission in June. create a framework for action to promote social justice at national, regional and international levels. They recognise that economic growth should promote equity and social justice and that "a society for all" must be based on social justice and respect for all human rights and fundamental freedoms.

For SOLIDAR, in times of crisis, social justice should be at the core of the necessary reform of the financial system as well as a more democratic and responsible international governance system.
