SOCIAL AFFAIRS

ASSOCIATIONS - SERVICE PROVIDERS AND FORCES OF SOCIETAL INNOVATION?

SOLIDAR member UNALG co-organised a conference of the national federation of French associations active in the field of child and youth welfare, education, disabilities and labour market insertion (FGPEP), held this Wednesday and Thursday in Nantes. These associations are facing far-reaching reforms concerning not only the structures of public administration, but also and more importantly, the character of their relationship with public authorities.

In France and across Europe, a shift in the type of cooperation between public authorities and associations from being privileged partners building on a complementarity of tasks towards a relationship based only on public tendering and contracts for the provision of personal social services can be witnessed. This new environment, characterised by competition with other social economy organisations and for-profit enterprises, will very likely, in the long term, reduce the role of associations to one of sub-contractors of public policies and service providers, filling in gaps or focused only on the most vulnerable persons and/or economically disadvantaged groups. EUROPEAN COMMISSION REPORT ON SOCIAL PROTECTION AND SOCIAL INCLUSION

The European Commission published its [Annual Report on Social Protection and Social Inclusion](#) (in all EU languages) last week. The report highlighted the fact that 16% of Europeans are living at risk of poverty and 8% of workers are still below the poverty line; but with the financial crisis, these figures are likely to keep rising. SOLIDAR is in agreement with the main messages of the report which concentrate on the social impact of the crisis and the need for an adequate social response, but we do find that the report lacks measures on how to make progress on social exclusion and poverty and to deliver on the overarching objectives of the open method of coordination (OMC).

SOLIDAR believes that what is really needed to increase ownership and to tap the full potential of the social inclusion strategy is a more active involvement of the European Parliament and national Parliaments in the OMC process. Furthermore, SOLIDAR calls for a robust social policy strategy and strengthened OMC to support employment and the creation of quality jobs as well as to implement quantified targets and indicators on poverty. The campaign is led by Building and Wood Workers International (BWI) and its South Africa Construction sector affiliates, SOLIDAR Global Network partner the Labour Research Service (LRS), and in partnership with SOLIDAR member Swiss Labour Assistance (SLA), who also campaigned to promote the same aims around the UEFA championships in Switzerland and Austria in 2008.
