ACTIVE INCLUSION REPORT

The European Parliament's Employment Committee adopted an own-initiative report on [Active Inclusion](#) on the 31 March. SOLIDAR was strongly involved in contributing to the process of drafting this report and we are happy to say that all main suggestions made by us, together with some other Social Platform members, were taken up.

Notably, our request that active inclusion policies should be consistent with a lifecycle approach to education, life-long learning, social and employment policies and that they be tailor made, targeted and needs-oriented. As well as our request that the follow-up on active inclusion be coordinated together with the process on the voluntary framework for social services due to overlapping issues on minimum income.

INTERNATIONAL COOPERATION

SOLIDARITY RALLY TO GET PALESTINIAN WORKERS FROM EAST JERUSALEM BACK TO WORK

WAC, the Workers Advice Center in Israel, has launched a solidarity campaign to get 21 Palestinian workers from East Jerusalem back to work with full social rights in the Antiquities Authority (AAI) of Israel. The archeological excavation workers, residents of East Jerusalem, were illegally fired at the beginning of January 2009 by the Authority and Brick manpower company through which they were hired, violating the stipulations of the law requiring that they be hired directly through the Antiquities Authority ([for a full account](#)).

SOLIDAR fully supports this campaign which is calling for all workers to have a decent job and working conditions. WAC are tonight holding a solidarity rally with both Israeli and Palestinian artists to raise contributions for funds to help the workers survive during the period of the struggle. BREAKING NEWS FROM EGYPT: FIRST INDEPENDENT UNION CREATED

On Wednesday, after a protest that lasted more than 5 hours in front of the Egyptian Labor Force Ministry, Real Estate Tax Authority (RETA) employees succeeded in submitting their application for the creation of the first independent union.

The delegation representing the protesters conducted negotiations with the Minister of the Labor Force. The discussions ended with the agreement by the Minister to accept the submission of the application for the union. With this step, the workers of the RETA have set a precedent in the history of the Egyptian Labor Movement by establishing the first independent union out from under the umbrella of the official trade union confederation, which is dominated by the government. TRIBUTE TO JACK JONES

It is with great sadness that SOLIDAR learnt of the death of Jack Jones, the leading UK trade unionist, who received a SOLIDAR Silver Rose Award Life Time Achievement Award in 2003 for his great work and achievements.

Jack led the Transport and General Workers' Union (TGWU) from 1968-1977. Under his leadership the TGWU reached a membership of 2.2 million, at the time the largest union outside the communist world. He democratised trade unions and was a strong internationalist. Jack will be sorely missed.

On 18 April, nearly 10.000 workers, representing all six Hungarian trade union confederations including SOLIDAR partner MSZOSZ, demonstrated for a socially balanced economic crisis management in front of the Parliament in Budapest. A petition by the six confederations was handed over to the Hungarian government and three parties of the Parliament calling for meaningful dialogue and immediate negotiations at the tripartite interest reconciliation council.
