SOLIDAR members are still active in Sri Lanka although their staff have undergone severe problems and strong pressure from both sides. For more than a year, humanitarian aid projects and demining have been made impossible in the North of the country, a way of getting rid of NGOs testimonies of what is really going on there. And now the Internally Displaced Persons have been taken as hostages and prisoners.

Sri Lanka does not need a pretense of victory, but a project for the future with the government being held accountable for the human rights abuses going on, and NGOs being given access to all areas of the country and able to work under secure conditions to provide help to the people in need.

As an important sign of solidarity with the Sri Lankan people, the next SOLIDAR Annual General Assembly will vote on a motion on Sri Lanka; to help and aid a population in need.

SOCIAL AFFAIRS

TOGETHER FOR SOCIAL EUROPE: NATIONAL SEMINARS

This week SOLIDAR members Arbeiterwohlfahrt and Czech Council for Foreign Relations organised national events in the framework of the "Together for Social Europe" campaign. SOLIDAR participated in a meeting with Arbeiterwohlfahrt regional representatives working in the field of in-patient and out-patient services and institutions for persons with disabilities in Berlin. SOLIDAR focused on the ongoing debate and policy process around a voluntary quality framework for personal social services at European level. Participants of the seminar were critical about defining quality standards at European level, however supported the idea of developing common quality principles and a methodology to promote quality management and assurance systems.

On Wednesday SOLIDAR then participated in a seminar on migration and integration organised by the Centre on Multiculturalism in Mladá Boleslav, Czech Republic, in close collaboration with SOLIDAR member Rada Pro Mezinárodní Vztahy and bringing together stakeholders, local decision-makers and representatives of the central government. The purpose of this meeting was to present and discuss results of a study on the situation of migrant workers in the Czech Republic, mainly looking at their working conditions and challenges regarding their integration and access to services at a local level.
