The European election campaign comes to its end as the 'four days of truth' begin. And provisional results from the UK and the Netherlands are everything but encouraging. Strong votes for extremists are not the answer to the current crisis, but are simply translating the feeling of insecurity that is being felt by people in Europe; this is not only a momentary hiccup, but a real challenge for all democratic and progressive forces.

We in SOLIDAR are part of those who believe that we cannot just wait for the crisis to pass, like the weather, and then continue as before. What we want is real commitment for a more Social Europe and Decent Work for all, and a Europe that sends clear messages to its citizens, unlike the timid messages on jobs and employment in its Communication on Employment released this week (see below).

And we now have to start the campaign for another Lisbon Agenda which will not only be based on jobs, growth and competitiveness, but also on social cohesion and sustainable development. Social protection, quality jobs and policies with a focus on the general interest are THE competitiveness factors of Europe, they are at the heart of the European Social model.

So, together let's work for:

- Equal opportunities for all
- Investment in social infrastructure, public services and social services of general interest
- Policies of social and territorial cohesion
- Decent work for all
- Decent life for all citizens living in Europe

### SOCIAL NGOs DISAPPOINTED BY COMMISSION COMMUNICATION ON EMPLOYMENT

This Wednesday, the Commission adopted a [communication on employment](#) ahead of the June Spring Council meeting. Although some points that the Social Platform brought up beforehand ([contribution to Employment Summit](#) and [open letter to Commission President Barosso](#)) were mentioned, on the whole, the Communication is just proposing to continue with the usual policy agenda that focuses on labour market supply side measures only and does not reflect the current urgencies stemming from the crisis, which also need active labour market policies and investment in social infrastructure. ## INTERNATIONAL LABOUR CONFERENCE AIMS FOR GLOBAL JOBS PACT

This week SOLIDAR attended the opening week of the ILO's International Labour Conference, which this year has dedicated itself to concluding a Global Jobs Pact in order to aid countries in dealing with the economic crisis.

The first three days have been dedicated to looking at various impacts of the crisis, as well as possible solutions. In its latest [Global Employment Trends Report update](#), the ILO puts the number of newly unemployed in 2009 due to the crisis at between 39 and 59 million. This is in addition to the growth of poverty and informality, which has had grave effects on women in particular. Much of the debate has centered around the question of whether we are seeing signs of the recession relenting, and how long the recovery will take, with most predicting that since the crisis is truly global it will take a long time for economies to recover. ## MOMENTUM TO IMPROVE TRANSPARENCY AND EFFECTIVENESS OF EU DEVELOPMENT FUNDING

SOLIDAR participated this week in CONCORD's Financing for Development and Relief NGOs working group. This working group focuses on EU funding policies, priorities, modalities and allocations to non-state actors and NGOs involved in international development and humanitarian work.

There is currently real room for negotiation with the Commission to change and improve its funding for development processes. The Commission has signed the [Accra Agenda for Action](#), in which it commits to engage with civil society actors following a series of very critical evaluations, and has recently reiterated its interest in pursuing the [Palermo process](#) in the summer 2010. There is thus a good momentum building up to increase the involvement of both EU and Southern NGOs, and to improve the transparency and effectiveness of the EU development funding processes.
