SOLIDAR has already launched a briefing paper: [A new direction for Europe: 10 priorities for the new Parliament and Commission](#). We will further this work with the European institutions in autumn by carrying out **5 expert round tables in the European Parliament** on our core topics of social services; decent work in Europe; migration and education; decent work and trade; and social protection and development.

Another date for your diaries: **7 October - the World Day for Decent Work** - which this year will be handing over the thousands of signatures from around the world supporting the Decent Work concept to key decision makers in Europe and international institutions. SOLIDAR alongside our partners in the Decent Work Alliance will be organising a worldwide stunt, so make sure that you don't miss it!

Today, SOLIDAR also launched our new project '**Decent Work for All: A Key for Effective Industrial Relations**' at a conference with guest speakers from the International Labour Organisation, the European Parliament, the European Commission and the European Public Services Union. This grouping shows once again the pivotal role that SOLIDAR plays as a bridge-builder between European institutions, trade unions, and civil society organisations from the social and development sectors (read more below).

A few key moments over the past week have been addressing the **informal meeting of Employment, Social Affairs, Health and Consumer Ministers** in Sweden, in my capacity of President of the Social Platform, voicing the message that for social NGOs, Europe is about solidarity, social inclusion and how the most vulnerable can be integrated, not just in the labour market, but in society (read more below).

And SOLIDAR was also present at the [Gsott8](#) pre-G8 mobilisation event in Sardegna, organised by our Italian member Arci. This very impressive coalition of NGOs brought a strong message to the G8 summit, to bring the economy, democracy and politics back to the needs of the local community whose needs and resources are usually destroyed by the model of development in which we live.

In the autumn, we will use the opportunity to work together with progressive and democratic political forces to change the current paradigm and advocate for a new **Lisbon Agenda** focusing on social cohesion and not on economic growth.

The Weekly Round Up is also going on holiday over the summer and will be back at the end of August.

SWEDISH PRESIDENCY OF EU

At the kick-off conference held this morning in the presence of [project partners](#) and guest speakers Rudi Delarue from the International Labour Organisation, Frank Siebern-Thomas from DG Employment, Jan Cremers - former Member of the European Parliament, and Penny Clark from the

European Public Services Union, Conny Reuter opened the conference by saying "decent work is more important than ever in this time of crisis and continued investment in social protection is vital".

The project, funded by the European Commission's DG Employment, entitled 'Decent Work for All: A Key for Effective Industrial Relations' aims to gain a better understanding of the link between decent work for all and effective social dialogue in view of reinforcing the European Social Model, and the necessity to place decent work at the centre of EU measures to counteract the current financial and economic crisis.
