Parallel to this, the financial markets continue to function on the basis of a model which has shown its inherent dangers and failures; and it is not only the problem of a few, but of an entire system. We need to seize this opportunity to better regulate and ensure more transparency and control of the financial markets. ANNIVERSARY CELEBRATIONS

On Tuesday, Finnish members, Workers' Educational Association (TSL) celebrated its 90th Anniversary. Conny Reuter, Secretary General of SOLIDAR was present at the event. Pia Vitanen, President of TSL commented that *"TSL is committed to foster democracy, equality, tolerance and lifelong learning. We underline the importance of international activities, as well. TSL encourages discussion about global and social phenomena. In our opinion global rights and responsibilities require common ground rules and cooperation across country borders"*.

Last week, German members Arbeiterwohlfahrt (AWO), also celebrated their 90th Anniversary with a big event for citizens and members in Dortmund. 90 years of fighting for equal opportunities, advocacy for social rights and progress, solidarity and tolerance and a strong welfare state. UPDATE ON TOGETHER FOR SOCIAL EUROPE DECLARATION

After the Together for Social Europe conference last April brought the experiences of social workers working with poor and vulnerable people to the heart of EU democracy, the European Parliament, a [Declaration](#) was launched by 50 social workers and SOLIDAR members from all over Europe elaborating 6 main fields of action and concrete proposals to the European institutions on how to improve social Europe. DECENT WORK AND INDUSTRIAL RELATIONS: IS EUROPE FAIR TO ITS WORKERS?

Due the increasing number of non-standard contracts, like temporary agency work and on-call work, the principle of equal treatment between workers (which forms a pillar of the decent work concept) is not being ensured in the EU. This is one of the main conclusions of a study on ['The Impact of New Forms of Labor on industrial Relations and the Evolution of Labour Law in the European Union'](#) commissioned by the European Parliament's Employment Committee and presented this week during the Committee session. DOMESTIC WORKERS MEET

The Global Network - Asia Regional seminar took place in Hong Kong on the 16-17 August and this year focused on the preparations for the International Labour Organisation (ILO) Convention for Domestic Workers.

SOLIDAR President Josef Weidenholzer and International Cooperation Coordinator Andrea Maksimovic joined over 40 domestic workers from Hong Kong, Indonesia, the Philippines, mainland China, as well as representatives from Pakistan, Bangladesh, India and Malaysia in discussing the situation for domestic workers in Asia and the necessary steps that need to be taken in order to ensure that at its next international conference, government members of the ILO agree to a strong convention ensuring their protection.
