INTERNATIONAL COOPERATION

THE ROLE OF EUROPE FOR PEACE IN THE MIDDLE EAST

SOLIDAR's President, Josef Weidenholzer, and Cooperation in the Field Officer, along with members Progetto Sviluppo and ARCI, travelled to Jerusalem on 12-13 October to take part in the International Conference on "the role of Europe for Peace in the Middle East". The initiative gathered together over 500 participants representing local authorities and civil society organisations (CSOs) from Italy, France and Spain with Israeli and Palestinian NGOs, academics, municipalities and CSOs to reflect on the role and responsibilities of Europe and the international community in supporting a just and sustainable peace process in the region.

Speaking at the conference, the SOLIDAR President stressed the important role of civil society in the process as demonstrated in Europe when nations had to rebuild peace after years of conflict. He finished by saying that dialogue and non-violence underpin the path to sustainable peace.

CONCORD REPORT SHOWS EU POLICY INCOHERENCY IS DAMAGING DEVELOPMENT

Responding to the Commission's Communication and report on Policy Coherence for Development, CONCORD released a [report](#) on Wednesday appealing for Europe to stop harming developing countries with its policies. The "Spotlight on Policy Coherence" report looks at the damaging impact that EU policies such as trade and agriculture are having on developing countries, effectively undoing all of the potential achievements of its development aid. COMMISSION NEEDS TO SHOW SOLIDARITY WITH WESTERN BALKANS

The European Commission published a new Communication on enlargement on 14 October, made up of the strategy outline for the upcoming two years and of 8 annual progress reports. Although there is optimistic news on progress in Croatia and the Former Republic of Macedonia, there are several points that cause anxiety: the overall economic crisis seems to have hit the applicants hard, resulting in less export, less investment and therefore higher unemployment.
