## INTERNATIONAL COOPERATION

### CONFERENCE: IMPACT OF THE EU TRADE POLICY ON DECENT WORK

On Wednesday and Thursday this week, a conference, hosted by Kader Arif MEP, on the impacts of the EU's *Global Europe* trade strategy on decent work took place. This event brought together MEPs and representatives from trade unions, the Commission's DG Trade, business and international organisations. The exchange of views by people with very different backgrounds and interests resulted in highly interesting and fruitful discussions on how to guarantee sustainable development, of which decent work is a part, in the trade agreements that the EU is negotiating.

Particular attention was given to the impact of the financial and economic crisis, that is now turning into a jobs crisis, and the fact that as a result of this crisis we can see that the current trade model based on export-led growth simply does not work. SOLIDAR, together with its Global Network partners, stress that the mere objective of trade liberalisation will not necessarily guarantee the preservation of jobs and decent work in the countries that are trading partners of the EU. What is rather needed is a modification of the current EU trade strategy *Global Europe* to include the concept of decent work as a main aim. [Read our media release...](#)

### DECENT WORK AND MULTINATIONAL SUPPLY CHAINS

How can multinationals be made accountable for the denial of decent work to their workers? This was one of the central questions raised during the seminar on the business of labour rights held on Tuesday in the European Parliament organised by War on Want, ECCJ and SOLIDAR, and hosted by Pervanche Berès MEP, Kader Arif MEP and Richard Howitt MEP. Some 45 people including MEPs, representatives from NGOs, trade unions and the European Commission exchanged views on how to implement corporate accountability in order to effectively improve working conditions in developing countries. Testimonies by Anton Marcus (Free Trade Zone Trade Union Sri Lanka), Astrid Valencia (Grupo de Monitoreo Independiente de El Salvador) and Dharmendra Kumar (FDI Watch India) illustrated the working conditions that workers face because of irresponsible corporate behaviour.

After last week's positive announcement by the Swedish Presidency that it is looking to operationalise the Protect, Respect and Remedy framework on corporate accountability developed by John Ruggie, SOLIDAR is hoping that the Spanish Presidency will actually walk the talk and implement the suggestions of this framework. SOLIDAR also calls on MEPs to organise a hearing about access to justice within the EU for non-EU victims of irresponsible corporate activities and a parliamentary resolution on the establishment of a legal framework for EU companies to respect workers' rights abroad. ## SOCIAL AFFAIRS

### WEBSITE LAUNCHED ON THE POSTING OF WORKERS

The construction industry is characterised by the high mobility of its workforce. In this framework, the Posting of Workers Directive constitutes a central piece of European legislation, aimed at regulating the movement of workers posted from one EU country to another. European social partners in the construction industry, with the support of the

European Commission, recently launched a [website](#) that focuses on legal provisions and regulations affecting construction activities, with the aim of helping firms and workers identify those national legal and conventional provisions which have to be respected when workers are posted from one EU country to another.

In SOLIDAR's view this website is a useful tool to highlight the benefits of joint efforts by employers and trade unions to broaden the knowledge base on labour law (for example, minimum wages, working time and minimum rest) and social protection (like health and safety at the workplace) issues related to the posting of workers. It should support efforts to promote decent working conditions for posted workers across the EU27. Interpretations of the European Court of Justice in its 2008 rulings Viking, Laval, Rüffert and Luxembourg/Commission have raised [serious concerns](#) by trade unions and social NGOs, including SOLIDAR about an unbalanced relationship between fundamental social rights and economic freedoms and the negative effects this has on individual and collective labour law.
