SOCIAL AFFAIRS

CROSS-BORDER HEALTHCARE DIRECTIVE PUT ON HOLD

At the end of April, the EP voted on a [proposal for a directive](#) on the application of patients' rights in cross-border healthcare, excluding services in the field of long-term care, after fierce disputes concerning the appropriate legal basis, concepts used and a number of concrete stipulations. But in the EPSCO Council on 1 December, conflicting positions concerning the reimbursement of costs of cross-border health care for pensioners permanently residing outside their country of affiliation and for providers not contracted to the mandatory health care funds could not be reconciled. It is now up to the Spanish and Belgian EU Council Presidencies to continue negotiations in view of a compromise.

SOLIDAR had welcomed the strengthening of patients' rights in cross-border healthcare, however also warned against stipulations most likely creating or not reducing inequalities in access to these services (see [full position](#)), as also done by the European Public Service Union (EPSU) (see [position](#)).

TOGETHER FOR SOCIAL EUROPE: NATIONAL SEMINARS

INTERNATIONAL COOPERATION

PRESSURE ON EU BUILDS TO SUSPEND TALKS OVER FTREE TRADE AGREEMENT WITH

COLOMBIA

The European Union is coming under increasing pressure to stop negotiations with the Columbia for a Free Trade Agreement given the impunity of the Columbian government shown in the face of murders of trade unionists and indigenous activists, as well as its general disregard for human rights. Similar deals with the US, Canada and EFTA countries have all been delayed due to human rights concerns. SOLIDAR wrote to the EU Trade Commissioner earlier this year demanding that Columbia be suspended from the EU's trade preferences regime GSP+ and that the talks over an FTA be suspended until the government showed its willingness to address the situation. WTO DOHA ROUND OF TALKS NOT MUCH CLOSER TO CONCLUSION

The World Trade Organisation held its 7th Ministerial from the 30-2 December in Geneva. SOLIDAR Secretariat, members as well as our partners from the Global Network and allies from the ITUC participated in a range of side and lobbying events during the 3 days, as well as following the debates and discussions during the conference itself. FAIR FLOWERS FOR HUMAN RIGHTS

SOLIDAR member Volkshilfe Austria, FIAN Austria and other partners have been carrying out urgent actions as part of the campaign: [Fair Flowers for Human Rights](#) to raise awareness of the working conditions in two flower farms in Colombia. The 400 workers in these farms had not received social benefits for years and were not receiving regular salary payments, so they went on strike, backed by the independent Colombian trade union [Untraflores](#). The flower farms refused to pay out compensation and pressured workers to quit, amongst which many single mothers, using the financial crisis as the excuse.

FIAN then launched an urgent action urging the Colombian government to act against the violation of human rights. The workers are now filing individual lawsuits to receive compensation, supported by Untraflores, and will continue the struggle for justice - already one of the claims has been successful. The campaign will continue with a series of actions at the beginning of 2010, including one in the European Parliament in Brussels. [Read the full story...](#)
