

This month gender equality has been in the spotlight with the 100th edition of International Women's Day being celebrated on 8 March; the review of the implementation of the Beijing Platform for Action - vital in the achievement of Millennium Development Goal 3 on gender equality -taking place at the beginning of March; and the launch of an EU campaign on the gender pay gap on 3 March.

In Europe, the Lisbon Treaty's Article 13 provides a framework for the development of policies for non-discrimination based on gender however this does not change the fact that there is still a 17.4% pay gap in the EU. In recent years there has been little progress in reducing it, and more worrying still, in some Member States the gap is even widening.

In developing countries, progress has been made but until violence against women stops and women, especially migrant women, have more access to basic services and public health, gender equality cannot exist. These issues were debated in Cape Town on 7 March by Global Network partners.

The journey has started but there is still a long way to go.

EU EMPLOYMENT POLICY - VIEW FROM SOCIAL NGOS

With the new EU2020 Strategy, comes a new European Employment Strategy. How does this work? Two parallel processes are currently taking place. The European Commission will make a proposal, following the Spring Council on 25-26 March. And the European Parliament will make a report on Employment Guidelines to be voted in May or September. These feed into the process and the Commission proposal should be voted on at the June EU Summit. It is not yet clear if the national parliaments will be involved in the process for the subsidiarity check, implementing for the first time this new stipulation of the Lisbon Treaty in the fields of social, health and employment policies.

What does SOLIDAR want from the new strategy? SOLIDAR will advocate for having guidelines on 1) active inclusion/inclusive labour markets, 2) quality work and employment/decent work, 3) lifelong learning, 4) labour market access of people facing disadvantages and groups experiencing discriminations and 5) the reconciliation of professional, family and private life.

EUROPEAN MONETARY FUND: A NEW LENDER OF LAST RESORT?

The idea behind the European Monetary Fund is to create a lender of last resort when governments are facing bankruptcy and with the aim of providing stability for the euro currency. In itself it is not a bad idea but the fact that Olli Rehn, the European Commissioner for Economic and Monetary Affairs, has emphasised that any financial aid from a European fund would be linked to "strict conditions" should send alarm bells ringing. HAITI SOLIDARITY PARTY

Last week, SOLIDAR in partnership with a dynamic group of young activists from the Socialist Youth of Spain (JSE) - and with the support of its members Solidarité Socialiste, the PES and S&D group- organised a fundraiser event in support of Haiti at the Café 'La Maison du Peuple' in Brussels. The Haiti Solidarity Party was a real success and attracted an impressive crowd of people from European NGOs, activists and the general public.

ENDORSEMENT OF THE GOLDSSTONE REPORT BY THE EUROPEAN PARLIAMENT

SOLIDAR welcomes the endorsement by the European Parliament of the UN's highly contested Goldstone report that condemns Israel in particular of war crimes during the bombardment of the Gaza strip in January 2009 and calls for the prosecution of Israeli officials in The Hague.

In a 335-to-287 vote splitting the house between left and right, MEPs backed a joint resolution calling on the EU's foreign policy chief Catherine Ashton and the Member States to demand an implementation of the report's recommendations. We now call on the EU and its Member States to implement its recommendations.

A NEW DIRECTION FOR EUROPE IN THE WESTERN BALKANS

A strong role for civil society and civil society organisations is a pre-requisite for the success - on local, national and regional level - of the EU enlargement process; to raise awareness amongst people on political developments, engage citizens in decision making processes and provide critical analysis on social and economic developments.

In order to support the work of the European Commission in engaging civil society in the enlargement process, SOLIDAR has developed - with the support of organisations from the Western Balkans - 5 key recommendations for the new European Commissioner for Enlargement and Neighbourhood Policy.
