

This week EU Finance Ministers met in Brussels, where discussions focused on the situation in Greece and the 2009-2010 fiscal stimulus packages. Ministers concluded that Greece is on track to achieve the goal of reducing its deficit by 4% in 2010 due to the efforts of Papandreu's PASOK government.

For us, the social crisis facing Greece should serve as a warning bell that the Growth and Stability Pact must be reviewed in order to ensure that slashing wages, pensions and social services is NOT the only policy tool available to governments in times of crisis. The pursuit of such policies can only lead to more social unrest and greater suffering for the population.

Further, we believe that moving away from the fiscal stimulus packages in 2010 is a mistake which could lead to even greater unemployment, increasing inequality and hampering the recovery; exactly the opposite to the EU2020 strategy's aim. Such a withdrawal should only be considered once employment rates have reached their pre-crisis level and quality.

Finance Ministers have to look at the figures and serve the people first!

## INTERNATIONAL COOPERATION

### EU-ISRAEL ASSOCIATION AGREEMENT UPGRADE CONTINUES

With the tension between the US and Israel on the construction plans in East Jerusalem escalating and despite a political decision by the EU in June 2009 to put negotiations on hold, the EU is still working with Israel to upgrade the EU-Israel Association Agreement.

Since the last Association Council meeting in June 2009, Israeli violations of international human rights and humanitarian law have continued. Further, Israel rejected the Goldstone report, a UN fact-finding mission on the Gaza Conflict, and Israel has not yet lifted the blockade on the Gaza strip. The EU should take a stand and publicly declare that an upgrade of EU-Israel relations will really be on hold if Israel does not start to respect human rights and international humanitarian law.

### EU-COLOMBIA FTA: CAN WE IGNORE ONGOING HUMAN RIGHTS VIOLATIONS?

A few weeks ago technical negotiations on the Free Trade Agreement (FTA) between the EU and the Colombian government were finalised, despite ongoing human rights violations in the country. ### TARGET TO LIFT 20 MILLION PEOPLE OUT OF POVERTY ESSENTIAL IN EU2020 STRATEGY

With the upcoming Spring Summit next week (25-26 March), EU leaders will agree on the headline targets in the EU2020 Strategy. SOLIDAR would like to emphasise that it is essential to include the proposed target to lift 20 million people out of poverty in the EU as measured by the relative poverty indicator. SOLIDAR and other social NGOs view this as a potentially historic, albeit interim, step forward for EU cooperation in the fight against poverty and social exclusion.

In addition, SOLIDAR is in favour of defending an autonomous Social Open Method of Coordination (OMC), but with a specific social guideline in the Integrated Guidelines that requires delivery on the poverty target and progress on the common objectives of the Social OMC.
