Currently Europe is going through a period of crisis. This started one year ago with a financial crisis, the social consequences of which have affected European and developing countries with mounting unemployment and a reduction in quality and decent jobs. And now the same bankers who were bailed out by European governments with billions of dollars are now speculating and ultimately ruining any chances of Greece, and now Spain, get out of the grips of national debt crises.

The response from European countries is generous - 110 billion dollars for Greece - but not done in solidarity as conditions mean that Greece must cut public sector wages, jobs and expenditure by 16%. No wonder the polls are showing a rise in nationalism when members of the European Union are no longer standing side-by-side.

## SOCIAL AFFAIRS

### HOW CAN THE EU'S EMPLOYMENT POLICIES BEST COMBAT POVERTY AND SOCIAL EXCLUSION?

Following the release by the European Commission of its proposal for the "EU2020 Integrated Guidelines" on 27 April ([read our assessment](#)), SOLIDAR sees that there are two ways that EU policies can help combat poverty and social exclusion. Firstly, by including key policy objectives in Guideline 10 on the promotion of social inclusion and the fight against poverty: access to affordable and high quality (social) services, effective anti-discrimination measures, a strengthening of the role of the social economy and explicitly including the aim of a substantial reduction of in-work poverty.

Secondly, that Member States agree on the well-established relative poverty indicator of 60% of median weighted household income that could be complemented by other poverty thresholds (40% and 50% of median income) and indicators on material deprivation. This indicator would be to measure the EU headline target on poverty reduction - 25% reduction of those living below national poverty lines - as suggested by the European Commission in its [Communication](#) on the 3 March.

### LAUNCH OF SOLIDAR BRIEFINGS ON DECENT WORK & INDUSTRIAL RELATIONS

Last month, SOLIDAR together with partners, organised various round tables in the framework of the 'Decent Work & Industrial Relations' project all over Europe. ## INTERNATIONAL COOPERATION

### EUROPEAN COMMISSION APRIL PACKAGE ON DEVELOPMENT FORGETS DECENT WORK!

With a letter sent yesterday to Eva Joly, Chair of the Development Committee of the European Parliament, the [Decent Work Decent Life Campaign](#), drew the European Parliament's attention to what it sees as serious 'amnesia' in the [European Commission's Spring Package on Development](#).

Although the package does refer to the most vulnerable and calls for wide-coverage social

protection systems and social justice, it fails to mention and integrate decent work policies (freely chosen employment and full respect for rights at work - encompassing Core Labour Standards - social dialogue, and social protection - including health and safety at work) as a key response to achieve the Millennium Development Goals in the 5 years that remain.

As a consequence, no mention is made to how the EU envisages supporting progress to provide productive and decent employment for all including women and young people - where accelerated progress is needed according to the official UN MDGs Progress Report 2009 - and to assist countries to monitor and report effectively on employment indicators under MDGs Target 1B.

## HAITI: WHAT NEXT?

On 5 May, SOLIDAR together with member Solidaridad Internacional organised a round table to reflect on the roles, challenges and possible synergies that could support the reconstruction process in Haiti. Among participants were representatives of the European Commission (Aidco), the European parliament (MEPs, Development Committee), the Spanish Presidency and European Development NGOs (CONCORD, VOICE, Coordination Europe-Haiti, Oxfam International, VOICE, and SOLIDAR members ISCOS and ACPD).

The NGO CROSE, one of the most active Haitian civil society organisations network in the Southeast region, shared their experiences and gave their perspective on the reconstruction process in Haiti. At the end, the round table resulted into an interesting discussion highlighting the views and positions of the different European stakeholders on the issue.
