## **EUROPEAN PARLIAMENT CALLS FOR LABOUR AND ENVIRONMENTAL STANDARDS IN TRADE DEALS**

Yesterday the European Parliament adopted reports calling on the European Commission to include clauses on human rights, labour and environmental standards in international trade agreements. This is a significant step forward and we congratulate the S&D Group for having led that battle. Since the 2005 World Social Forum in Porto Alegre, SOLIDAR has been actively involved in the campaign for Decent Work for a Decent Life, as well as calling for the inclusion of binding human and labour rights clauses in trade agreements.

We need to ensure that people anywhere in the world have their human rights, including a right to a decent job, upheld, and we call on the European Commission to include the requests made in these reports in their upcoming communication on CSR as well as in the ongoing trade negotiations. Trade policy should promote sustainable development without focusing exclusively on opening markets for European companies. The new [EU trade agenda](#), launched on 9 November, is still far from this ambitious goal.

In parallel, we encourage progressives, free unions and civil society in China and other major manufacturing hubs to struggle for these rights to be implemented there!
