The summer period was full of buzz words: transfer union, economic governance, European Monetary Union, speculation, indignation, and - solidarity. The call for solidarity seems to be an old fashioned habit of progressive forces harking back to their values, but difficult to mainstream the concept in member states when public opinion is more oriented towards nationalism and egoism. But solidarity is the backbone of our societies!

Nevertheless the time may have come to turn the crisis into a chance for a progressive change. Within the debate on European economic governance, there are now calls for a third pillar in addition to the economy and finance: social cohesion! Over the last weeks, we have had a taste of the social unrest that result from austerity measures which simply lead to weakening economies, killing growth and raising poverty and exclusion levels.

Therefore we stand with all those who campaign for having a social pillar in European economic governance and call for significant investment in social programmes. Changing the Lisbon Treaty may be one method, but it might be good to first translate the social dimension of Europe 2020 Strategy into practice, and introduce a social pillar into National Reform Programmes. Dare a more social Europe!

More than 12.4 million people in Djibouti, Ethiopia, Kenya and Somalia are currently affected by the famine, which is the most severe food crisis of its type in the world for some two decades.

Rallying with the international community to feed the Horn of Africa, several SOLIDAR members are intervening with relief actions in the field in Ethiopia, Kenya, Somalia and Uganda.

### UN ANSWERS BEYOND 2015 LETTER

Time is running out quickly for achieving the Millennium Development Goals, and the debate is intensifying at the international level around whether we need a new set of goals to achieve the objectives outlined in the Millennium Declaration that better take into account the current realities and challenges of the world we live in.

In this context and in the framework of the [Beyond 2015 campaign](#), SOLIDAR co-signed a [letter to the UN Secretary General](#) lobbying the UN to take the lead in the process and to develop a participatory and inclusive process which enables civil society to take part in the development of the post-2015 framework. The UN deputy Secretary General responded to the letter highlighting, among others, that: the UN shares the view that the process needs to be participatory and inclusive, responding to the needs of those most affected by poverty.

### **CLOSING CONFERENCE OF THE "NETWORK OF EUROPEAN TRADE UNION ACADEMIES - BETTER INFORMATION AND TRAINING FOR TRADE UNIONISTS" PROJECT**

On 21 September SOLIDAR is organising a final conference closing the "Network of European Trade Union Academies - Better Information and Training for Trade Unionists" project run by SOLIDAR and the Europäische Akademie der Arbeit (EAdA) over the last year.

At the conference, "Social Europe" teaching material will be presented and a debate will be held on lifelong learning for active inclusion into the European Labour Market. ## ENLARGEMENT

### **PROMOTING COMMUNITY-BASED INITIATIVES FOR SOCIAL INCLUSION IN THE WESTERN BALKANS**

SOLIDAR organised together with Arbeiter-Samariter-Bund (ASB)'s South East Europe office a field visit to Bosnia and Herzegovina to learn more about projects related to the reconstruction of a first aid station (ambulanta) in Tjentiste, social housing and social support measures in the rural areas and initiatives for economic support and social inclusion in Ustikolina. The two day visit included discussions with SOLIDAR members AWO (Germany) and Volkshilfe (Austria) and local partners IDC and EDC (Serbia), SMART (Croatia), LIR (Bosnia) on ways to promote community-based initiatives.

The organisations agreed that increased investments are necessary by the Civil Society Facility under the Instrument for Pre-Accession (IPA) for community-based initiatives and activities to counteract the exclusion of people from economic life, social services, social networks and civic participation.

On the same occasion a steering meeting took place with the **Decent Work Balkan Network partners** to plan the work schedule for the autumn.

## EUROPEANS FOR FINANCIAL REFORM

### **FTT: PICKING UP AFTER THE SUMMER**

While waiting for the European Commission and in parallel the German and French governments to deliver on their promises to each develop a feasible proposal for a Financial Transaction Tax (FTT) on the European level, next week a high level meeting will take place at UNESCO in Paris followed by a strategy planning meeting for a European FTT, which will be attended by several national parliamentarians. This will be followed by preparations of the Alter Forum in Nice and Cannes coinciding with the G20 in November.

In the meantime Christine Lagarde, the new director of the IMF, has been welcomed with a letter, signed by many EFFF partners, including SOLIDAR, asking her for the possibility of a meeting ahead of the IMF and World Bank annual meeting at the end of September. The letter also referred to the recent and rather positive report published by the IMF on the feasibility of an FTT.
