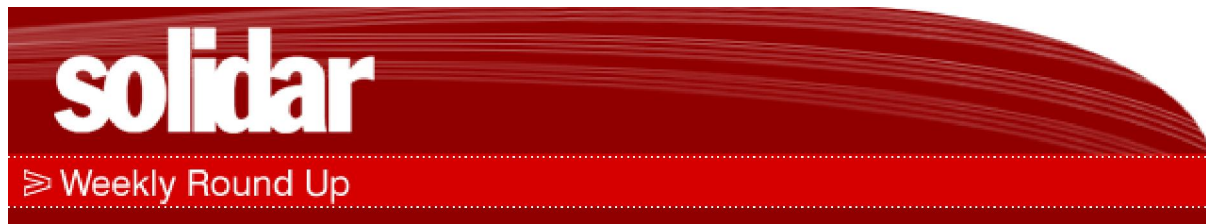

**IN REALITY, EQUALITY IS STILL NEEDED**

8 March is International Women's Day. Far from being an annual ritual, it is unfortunately still more than necessary to remind us all that even if we have achieved the equality of rights on paper, there is still a gap between the legal framework and the reality. For example, the European average gender pay gap of 17.5% still exists which puts European women at a greater risk of poverty than men, especially in situations of separation, divorce or death of their partner. In addition, in Europe, 7 women die every day from male domestic violence*.

At this week's SOLIDAR Silver Rose Awards (read article below), we had the pleasure to honour two women who are fighting for equal rights in very different settings: Iris Munguia has campaigned for decades for the rights of workers, particularly women, in the Chiquita packhouse where she worked in Honduras. And Nevin Öztöğ from Kaos GL has been carrying out crucial work in the streets of Turkey advocating for lesbian, gay, bisexual, and transgender rights and fighting all forms of discrimination.

There is still some homework to be done: whereas in civil society organisations we have an important female membership, women are often not enough represented in the leading positions in companies and organisations. The fight for equal rights and against discrimination is one thing, putting it into practice remains the challenge!

SILVER ROSE AWARDS 2012

On Tuesday (6 March), SOLIDAR celebrated the 12th edition of the Silver Rose Awards in the European Parliament, hosted by Véronique de Keyser MEP. The event this year heard contributions from European Commission, Laszlo Andor, and Staffan Nilsson, President of the European Economic and Social Committee, before getting down to the heart of the matter: the awards.

A special award was presented to **The Norwegian People represented by Prime Minister Jens Stoltenberg** and accepted by Niels Engelschion, Deputy Head of Norway to the EU and Ambassador to Belgium: *"This is a token that everyone has thought of us"*, he said before continuing: *"We have a democracy and no-one can destroy that for us."*

Iris Munguia was presented with a prize for her work campaigning for women workers' rights on banana plantations in Honduras. She accepted the award calling for *"a campaign for more stable jobs for women and zero tolerance against sexual harassment on banana plantations"*.

Nevin Öztop from Turkish LGTB organisation **Kaos GL** was presented with the award for their work campaigning for the rights of LGTB people in Turkey: *"This award goes to every LGTB human being in this room, in Brussels, in the world, those who died for who they were or the person they fell in love with."*

Poul Nyrup Rasmussen, former President of the European Socialists, received a lifetime achievement award for his work in opening up political parties to initiatives by citizens and progressive civil society: *"No-one can change alone for the better, but we can change together"*, said Rasmussen.

On 13 March, EU Finance Ministers will decide on the future of the European Financial Transaction Tax (FTT). The EU-wide implementation of an FTT could make an important contribution to tackling the crisis and ensure that the threats resulting from highly speculative financial trading are kept at bay. However some Member States - like the UK and Sweden - are fervently opposed to the introduction of a tax on speculators.
