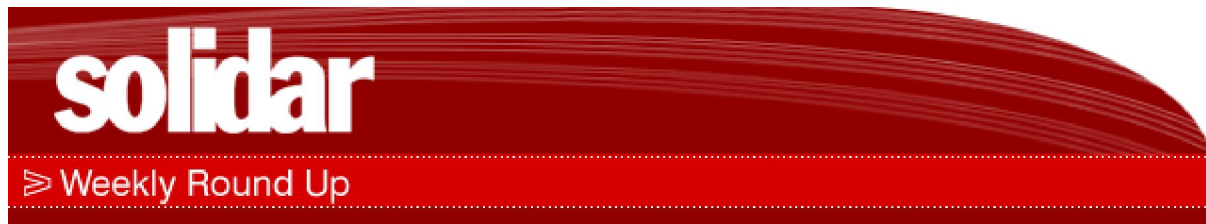

**EASTER SURPRISE?**

This week, Eurostat released the new [unemployment statistics](#) for Europe. They show that within one year, the number of unemployed people has risen by nearly 1.5 million in the Eurozone, with a huge disparity between countries like Spain, and Germany and Austria. Figures from countries applying austerity measures are anything but encouraging, with rising unemployment and social disintegration leading to desperate acts like the suicide of a [Greek pensioner](#).

As the European Commission's DG for Economic and Financial Affairs and the Council are focusing on fiscal and financial consolidation, more and more voices in Europe are concerned by the lack of investment strategy for jobs and sustainable growth. Where is the vision for a new industrial policy in Europe with huge job creation built on smart and sustainable development? In our sector, health and care, with an ageing Europe and a changing labour force, there is a real call for new jobs; but these jobs need to be stable, with decent working contracts and working conditions.

Social NGOs and social service providers approved the Voluntary European Quality Framework for SSGIs and believe that investment in training and quality jobs in this field can contribute to more employment, but to make this happen, we also need to see public investment in education and training. The Commission will soon present its employment package and we want to see intelligent proposals for pathways to decent work and quality employment, and not more flexibility and volatility. Proposals from networks like Social Services Europe and the Social Platform have been tabled.

SOCIAL AFFAIRS**A PLATFORM ON INNOVATIVE SOCIAL SERVICES: GET INVOLVED!**

SOLIDAR recently sent round a [questionnaire](#) to collect examples of innovative social services from all over Europe. The questionnaire is part of [InnoServ](#), a research project aiming to define what can be considered innovative in social services and to assess the added value of social innovation in the provision of more inclusive, affordable and efficient services.

SOLIDAR strongly encourages its members and other organisations representing social services providers to feed into the project and to circulate the questionnaire through their networks. The information gathered through this questionnaire will be used to realise a comparative report providing criteria to identify and evaluate innovation in healthcare, education and welfare services in Europe.

INTERNATIONAL COOPERATION**CRISIS SHOULD NOT BE EXCUSE TO REDUCE DEVELOPMENT COOPERATION CONTRIBUTIONS**

According to new [OECD figures](#) released on Wednesday, major donors' aid to developing countries fell by nearly 3% in 2011, breaking a long trend of annual increases. As [observed by CONCORD](#), almost all European countries are making cuts in their aid programmes to the developing world and for the first time since the start of the financial crisis, 12 EU countries have slashed their aid budgets. The biggest cuts were in Spain (-32.7%) and Greece (-39.3%), with substantial decreases in Belgium (-13.3%) and Austria (-14.3%).

SOLIDAR believes that cuts in development aid respond to a narrow, short term and austerity driven vision. Moreover, the 'rhetoric' of scarce available resources 'due to the financial crisis' should be combined, to be credible, with an active and constant action to look for new resources and innovative funding for development. Two examples among others: 1) support the establishment of a [Financial Transaction Tax](#) that would give billions to tackle poverty in Europe and abroad ; 2) Fight illicit capital flight which costs developing countries an estimated \$1 trillion a year (3% proceeding from corruption and over 50% from tax dodging by companies).
