QUALITY OF WORK AND EMPLOYMENT IN HEALTH AND CARE SECTOR

For SOLIDAR and other social service providers, the social services sector presents a huge employment and job potential. Employment in the sector grew much faster than in other sectors of the economy and it has important economic weight (generating around 5% of the EU 27's total economic output), with the social economy representing about 12% of the workforce in Europe.

Why is this sector still growing? Demographic change in Europe means an increasing need for health care and social services. But there are some recognised challenges to increasing the number of employees in the sector, namely an ageing workforce and the low attractiveness of the sector. Moreover, employment is often informal, not secure or part of social dialogue. The workforce is mainly female and often migrant women fill the gap of the lacking workforce.

On the European level, an EU employment strategy should be developed that seeks to seize the potentials of the sector, dedicates European funds to back this up and ensures the appropriate legal, political and financial environment so that social services can fulfill their mission. And under the following conditions: that it recognises the special characteristics of the services, the clients and the providers; integrates the education and training needs in the New Skills for New Jobs flagship of Europe 2020; and makes budget choices allowing for investment in education and training.

Additionally, Members States should support the improvement of working conditions in the sector by ratifying and implementing the ILO Convention 189 on "Decent work for domestic workers". This would be a way to create jobs and reply to Europe's growing social needs.

COMMISSION COMMUNICATION ON EU SOCIAL SECURITY COORDINATION

On 30 March, the European Commission issued a [policy communication](#) to clarify the social security rights of people migrating into and out of the EU. The aim is to ensure a better protection of workers' rights, in particular acquired state pension rights. Non-EU nationals make up around 4% of the workforce in Member States. Yet, the SOLIDAR network often sees a fragmented approach to existing social security coordination in the EU meaning that the portability of rights and benefits of migrant workers when moving to another country or to their country of origin are not guaranteed. EP REPORT ON PUBLIC PROCUREMENT SOON TO BE ISSUED

Last week, the Social Services Europe Network - of which SOLIDAR is a co-founder - issued a [position paper](#) on the Commission's proposal for a directive on public procurement. The document contains some suggestions to guarantee that the best possible conditions for the provision of high quality social services are integrated in the new directive.

The European Parliament is currently working on a parliamentary report on the Commission's proposal. Against this background, the Network for Sustainability in Public Procurement - of which SOLIDAR is a member - sent a proposal for amendments to the rapporteur, MEP Marc Tarabella (S&D). As affirmed yesterday during his speech at a seminar on Public Procurement, Tarabella appears to be in favour of the Network's suggestion to reinforce social and environmental considerations in the directive as well as being aware of the importance to provide the best possible conditions for the provision of social services of general interest.

INTERNATIONAL COOPERATION

WHY SOCIAL PROTECTION SHOULD BE AN ESSENTIAL PART OF EU'S DEVELOPMENT COOPERATION STRATEGY

On Wednesday (11 April), SOLIDAR and the European Working Group on Social Protection and Decent Work in Development Cooperation organised a Round Table on "Protecting People, Transforming Lives: Why social protection should be an essential part of EU's development cooperation strategy" at the European Parliament in Brussels. This Round Table came at a timely moment for CSOs to reiterate [their messages](#) as the EU is currently drafting a Communication on the topic to be ready by the end of the year.

During the meeting, around 40 people from the EU and NGO communities working on development cooperation discussed the role that social protection plays in fighting poverty and inequality. Conny Reuter, Secretary General of SOLIDAR, highlighted the importance of inclusive and universal social protection systems to realise economic and social rights for all and build a development cooperation agenda which aims to promote social justice. Ricardo Cortés Lastra MEP, who hosted the event, emphasized that European values should guide a values-based development cooperation policy. A full event report will be released shortly.

IPA II: MORE INVESTMENT NEEDED IN DECENT WORK, QUALITY EMPLOYMENT AND SOCIAL INCLUSION

On Wednesday, SOLIDAR issued a series of recommendations to feed into a Public Hearing organised by the European Parliament's Committee on Foreign Affairs on the future financing of enlargement, initiated by Kristian Vigenin (MEP).

The recommendations were based on the network's two year programme in the Western Balkans focusing on promoting decent and quality employment and strengthening a community-based approach to social inclusion. In addition to a consultation that was launched by SOLIDAR amongst social partners, think tanks, civil society organisations and community-based groups in the Western Balkans last month.
