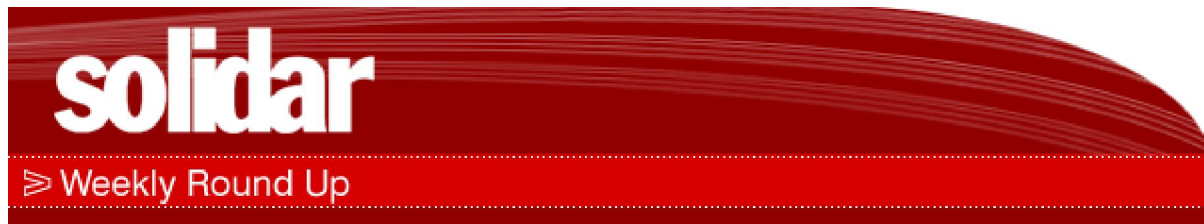

A PATHWAY TO JOB-RICH RECOVERY?

Yesterday (18 April), the European Commission presented its communication on how to help Europe recover from the crisis by boosting labour demand and exploiting the employment potential of some key sectors (read our full analysis below). The document recognises many issues that SOLIDAR and others have been calling for, such as the employment potential of the health and social sector and decent and sustainable wages.

The communication also underlines the need for social dialogue at a time where it is being sidelined by many Member States blindly applying austerity policies. It also recalls the agreement on pathways to flexicurity which were on our agenda in 2007. Finally, minimum wages are at least mentioned as a good example in some countries.

When it comes to the financial instruments, like the European Structural Funds (ESF), we can only reiterate that social NGOs want to see any conditionality deleted from the proposal and support strongly the Commission's proposal on earmarking 25% of ESF for social inclusion. The communication has certainly done a good job in identifying issues and making proposals. We will now see what difference it is actually going to make to the 24.5 million unemployed people in Europe, which will very much depend on the Member States.

INTERNATIONAL COOPERATION

GLOBAL NETWORK IN SRI LANKA CAMPAIGNS FOR DOMESTIC WORKERS RIGHTS

The Institute of Social Development (Global Network in Sri Lanka) together with the National Trade Union Federation, ACTFORM & National Workers' Congress have set up a "CCC 189 campaign committee" to demand the Sri Lankan government to ratify the ILO's Convention 189 on domestic workers. A signature campaign has been launched and is expected to collect 50,000 signatures to be handed over to the President of Sri Lanka. On 25 April 2012, the campaign committee will hold a public signature collection in front of one of Colombo's main railway stations.

GLOBAL NETWORK CONFERENCE: THE ROLE OF THE LABOUR MOVEMENT IN SHAPING THE INTERNATIONAL COOPERATION AGENDA AFTER 2015

On 22-24 May in Rio, the Global Network will have its [global conference](#) bringing together Global Network partners, trade union centers, progressive forces linked to the labour movement, and labour and human rights activists from at least 20 countries in Africa, Asia, Latin America, the Arab Countries and Europe.

Issues for debate include the right to social protection and the campaign for domestic workers rights. The conference will also provide the opportunity to hear about successful campaigns and projects, including experiences of people organising in the informal economy. As a result of the conference, a policy statement will be sent to government representatives participating in the ILO International Labour Conference and Rio+20 Summit in June 2012.

AWO CONFERENCE ON CARE

On the 17 April, SOLIDAR Member Arbeiterwohlfahrt (AWO)'s Bavaria hosted a conference on the current situation of care in Germany and Europe, with in addition, two sessions with care givers and relatives of people in need of care giving an insightful overview of current dilemmas faced. Participants agreed that the discussion on care as a moral right has to primarily focus on the needs of those affected.

SOLIDAR presented the ongoing European discussion on care. Other speakers included Thomas Beyer, Chair of AWO's Bavaria, Franz Wölfl, Bavarian Ministry for Labour, Social Affairs, Women and Family, Reiner Prölß, City Counsellor of Nuremberg, and Edelgard Bulmahn, former German Minister for Education and Research.
