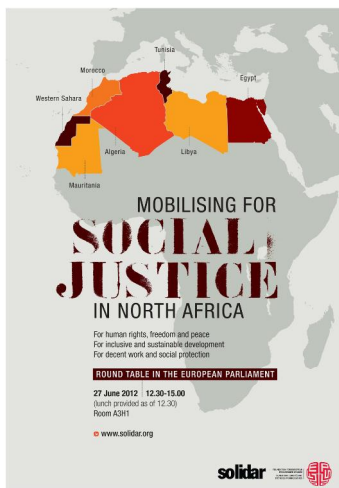

EDITORIAL: FROM AN ARAB SPRING TO AN ARAB AUTUMN?



Last year, progressives all over the world welcomed the changes in the Middle East and North Africa which took place during the Arab Spring. The turmoil that followed the collapse of old regimes however brought instability. One year later, the process has become more complicated; as the elections in Egypt and Tunisia, as well as the brutal repression in Syria which only last night killed 170 people have shown, the Arab Spring's promises for democratic transition have not yet become reality.

For SOLIDAR, independent and democratic 'actors for change' have a fundamental role to play in these democratic transition processes. They work for the development of a democratic pluralistic society and strive to bring the social dimension into the development equation.

Next week, on 26 and 27 June, SOLIDAR has invited 20 civil society organisations and trade unions from Algeria, Egypt, Morocco, Tunisia and Palestine to Brussels to identify together the challenges that lie

ahead in the region and to define - with our members active in the region - cooperation programmes that counteract the forces that promote inequalities and old power structures, which stand against social justice, human rights and democracy. [Read more...](#)

EU LEGISLATION ON STRUCTURAL FUNDS ENDANGERS PARTNERSHIP PRINCIPLE

This week, SOLIDAR [raised concerns](#) about the suggestions for the implementation of the partnership principle in the current draft report (2011/0276 COD) on the common provisions for the EU Structural Funds, which is about to be negotiated in the European Parliament. The current draft report endangers a genuine partnership that would set all relevant and competent stakeholders on an equal footing during the next programming period (2014-2020). Fifty per cent or more of our laws come from Brussels and it is vital that these policies work in the

interests of people and environment - not big business. Yet, the EU has a close relationship with corporate interests and many EU officials go through the 'revolving door' meaning that they leave their EU job and soon start working for industry or lobby firms, often in the same policy area. THE ENLARGEMENT PROCESS - CITIZENS ARE ASKING FOR SOCIAL CHANGE

[Decent Work Balkan Network](#) (DWBK) representatives [AGENDA Institute](#) (Albania), [Center for Democracy Foundation](#) (Serbia) and [Progress Institute for Social-Democracy](#) (Macedonia), were invited to discuss the (neglected) aspects of the social dimension of the Enlargement process at a [hearing](#) organised this week in the context of Maria Eleni Koppa MEP (S&D) draft report "Enlargement: policies, criteria and the EU's strategic interests".

Representatives from the region stressed that to avoid mistakes from past enlargements, the overall approach towards the region should be more integrated and good progress should be rewarded according to the more-for-more principle. In these difficult times of crisis, when the social agenda easily falls victim to austerity measures, the EU needs to keep combating poverty and social exclusion through a more sectoral focus and to push for a more inclusive approach to policy-making on all levels.
