

EDITORIAL: PARTNERSHIP? PARTNERSHIP!

How can social NGOs contribute to the implementation of the Europe 2020 Strategy? This was the topic of the meeting between the Social Platform and Troika at the informal meeting of the Ministers for Employment, Social Affairs, Health and Consumer Affairs (EPSCO) in Cyprus on Thursday. Indeed, social NGOs like SOLIDAR have expertise not only as European policy advocates, but principally because our members are at the forefront of the social consequences of this crisis and are finding responses to the urgent social needs and social challenges in a creative and **socially innovative** manner.

Yes, we are part of civil dialogue on EU level - which still does not work quite as it should - but apparently there remains reluctance or misunderstanding from certain EU stakeholders to fully include us in negotiations. Whereas the European Commission takes our contributions seriously, it seems that others have not understood the role of the "corps intermediaries" and what our field of competences are. If we do not have expertise, why would the EP's Regional Development Committee have put NGOs and social partners in the second row when it comes to the design and implementation of European Structural Funds, like the European Social Fund (ESF). PARTNERSHIP IN EU STRUCTURAL FUNDS SUFFERS HEAVY SETBACK

On Wednesday, the Committee on Regional Development in the European Parliament voted on the **Common Provisions Regulation** for EU Structural Funds (2014-2020), whereby they considerably weakened the sound proposal of the European Commission for a strong partnership in future funding programmes. This vote is of special consequence for SOLIDAR members as potential partners and implementers of programmes and projects under the European Social Fund or the European Regional Development Fund.
