Extended Time for Negotiations on EU Working Time Directive

Since last November European social partners have been attempting to conclude an agreement which would amend the existing EU Working Time Directive (2003/88/EC), and should be implemented by a Council decision. Unfortunately, the partners were not able to conclude these negotiations within the nine month period foreseen by the EU Treaty. In August, the European Commission therefore accepted their request to extend the time for negotiations until the end of the year.

International Cooperation

EC Communication on Social Protection in Development Cooperation Adopted

On 20 August, the European Commission published its [Communication](#) on Social Protection in European Union Development Cooperation. The Communication includes proposals on revenue reform for fiscal space, support for transformative social protection and the support for the National Social Protection Floors as a "well defined basis on which to build coordinated and, where possible, joint EU support for social protection with partner countries which decide to develop them" (section 8).

Global Network Africa Study on wage raise demand from South African mine workers

The [Global Network](#) coordinator for Africa, Labour Research Service ([LRS](#)), published a study on the incident that happened on 16 August at the Marikana mine in South Africa in which 34 workers were killed by the police. In the [study](#) LRS analyses the demand from the workers to double their wages to 12.500 rand (about 1200 Euro).

Migration

NGO Letter on EUROSUR

On Monday (3 September), SOLIDAR together with NGOs [AEDH](#), [PICUM](#), [JRS](#), [ENAR](#) and [REMDH](#), signed a [joint letter](#) sent to the European Parliament on the European Border Surveillance System (EUROSUR) requesting the establishment of a legal basis within the EUROSUR surveillance system proposal to guarantee fundamental rights for all migrants and asylum seekers. Currently, the EUROSUR initiative criminalises irregular migrants by emphasising the fight against organised crime and irregular migration. Furthermore provisions for search and rescue and the EU responsibility towards third countries are also neglected.

Education

Study Visit on Adult Education

One of the newest SOLIDAR member organisations, [AOF Norway](#), carried out a study visit in Brussels on 3-4 September. 15 AOF board members participated in sessions presenting the current status quo of adult education and the Lifelong Learning Programme at European level and the challenges in the field. This visit took place on the eve of the official presentation of a proposal for a Council Recommendation by the European Commission, which invites national governments to establish a [validation system for non-formal and informal learning](#).
