EPAP Convention on Future Social Investment Package

Last Friday (21 October), the European Commission organised a stakeholder meeting in preparation of this year's European Platform Against Poverty and Social Exclusion (EPAP), taking place from 5-7 December in Brussels. The meeting aims to discuss the integration of the poverty reduction target of the Europe 2020 Strategy in the European Semester and to exchange about the Commission's plans for a Social Investment Pact (SIP). Round Table: Protecting Domestic Workers Rights - What Is the Role of The EU?

On 17 October, SOLIDAR is organising a round table and film screening in the European Parliament on domestic workers rights and the EU's role in protecting them. An international standard was adopted in June 2011 finally recognising domestic workers as workers and not helpers (ILO C189). Yet domestic work remains one of the least protected sectors in many European countries and continues to be excluded from most European labour legislation.
