Editorial: Decent Work? Decent Work!

During the World Social Forum in Porto Alegre (Brazil) in 2005 SOLIDAR, together with the ITUC and other NGO networks, took part in the creation of the "Alliance on Decent Work for a Decent Life". Following the launch in 2007 of the global campaign, the ITUC instituted the World Day of Decent Work on 7 October, beginning in 2008.

When we started, none of us could have imagined the situation we face in Europe today, brought about by the ongoing crisis: 120 million people living in or on the verge of poverty, 25 million unemployed and almost the same number working for poverty wages. In the rich countries of the EU, the labour market is becoming more and more segmented, creating more indecent and precarious working conditions. In EU Members States faced with blind austerity measures, young people are particularly hard hit by the high levels of unemployment, resulting in the exodus of a whole young generation from their country in search of a decent life elsewhere.

MEPs call for a more social approach in international cooperation spending

The European Parliament's (EP) Development Committee adopted in September a series of amendments to the European

Commission's (EC) proposal for the **2014-2020 Development Cooperation Instrument (DCI)**. Based on their gross national income per capita, 19 countries have been removed from the list of aid programmes in the EC proposal, while many of them are still facing enormous challenges caused by poverty and inequality.

“Rights first!” campaign

On the occasion of the World Day for Decent Work, 7 October, the Decent Work Balkan Network launched a video in English and five local languages as part of the public campaign to raise awareness about the need to promote mechanisms that can guarantee basic rights and ensure decent work in the region. The aim is to also encourage those in precarious conditions, informal workers, future workers and the unemployed to get informed and demand their rights and better protection via existing socio-economic partnerships including NGOs, trade unions and the media.

New Briefing Paper: Building learning societies and the role of non-formal and informal (adult) education and training

SOLIDAR released a [new briefing paper](#) on 2 October. There are currently more than 120 million people living in poverty, or at risk of falling into poverty, within the European Union. Approximately 25 million people are unemployed, of which 5.5 million are young people, while 77 million Europeans still have only lower secondary education. To draw attention to this situation, SOLIDAR has submitted this briefing paper, including policy recommendations on the role of non-formal and informal (adult) education and training, to the Irish Minister of Education and Skills, Ruairí Quinn T.D., in preparation for the Irish EU Presidency in 2013.
