State of the Union: “Talk it up, or talk it down”?

On Wednesday, European Commission President Barroso presented his speech on the State of the Union to the European Parliament. He was right by saying that “Europe has been more present in the lives of citizens than ever before” by mobilising funds to help countries struck by the crisis and the like. He also drew attention to the social effects of the crisis without however providing any proposals for overcoming the increasing divide between rich and poor in Member States as well as between rich and poor Member States themselves. Education

Education Committee: A New Strategy for Lifelong Learning

On Monday (9 Sept), the Directors of SOLIDAR member organisations met in Paris, hosted by La Ligue de l’Enseignement, to discuss a new approach to promoting non-formal and informal learning (NFIL). Throughout the Union, austerity measures have resulted in severe reductions of budgets for NFIL while at the same time the number of young people who are not in employment, education, or training (NEETs) is growing rapidly, adult (work-based) learning is decreasing and social exclusion is increasing. Promoting Decent Work for Young People: Job Patrols

Last Thursday and Friday, SOLIDAR met with CGIL FILCAMS (Italy), IDEAS Institute (Ireland) and FIC (Denmark) to promote decent work and quality employment for young workers and young people who are not in employment, education, or training (NEETs). In times of crisis, when job opportunities are scarce for young people, a tremendous pressure can be witnessed on working conditions partly due to the lack of awareness of young people on their rights-at-work. Case studies have been developed in Italy, Ireland and Denmark underlining this trend. To overcome this awareness-gap, the organisations present agreed to develop new initiatives for “[youth job patrols](#)” where young people visit workplaces and promote decent work and quality employment.

Citizens’ Engagement in European Decision-Making Processes on National Level?

A commonly heard complaint is that national governments are forced by Brussels to make “hard” decisions, while in parallel these same governments have a strong influence in defining these decisions through the European Council. While national parliaments have a role in scrutinising government’s positioning and actively engaging civil society and citizens in the process, when it concerns European policies, this does not necessarily happen. Decent Work for Domestic Work: ILO C189 Entered Into Force!

Last week, on 5 September, the ILO Domestic Workers Convention (ILO C189) entered into force. The Domestic Workers Convention No. 189, adopted by International Labour Organization (ILO) members in 2011, aims at improving the working and living conditions of the estimated 50 to 100 million domestic workers worldwide.

To date, eight countries have ratified the Domestic Workers Convention – Bolivia, Italy, Nicaragua, Mauritius, Paraguay, The Philippines, and South Africa. SOLIDAR, its members organisations and the [Global Network](#) have been [actively supporting the campaign](#) to ensure Decent Work for Domestic Workers.
