Social Dimension of EMU - Window of Opportunity or Last Exit?

When Commission President Barroso announced last week in his speech on the State of the Union that the European Commission would put forward a communication on the social dimension of the Economic and Monetary Union (EMU), expectations were raised and doubts expressed. We social NGOs have been advocating for a strong social dimension since the publication of the blueprint. Why? Because the EU is not going to reach the objectives set out in the Europe 2020 Strategy and because growth alone does not guarantee less inequalities. [Read more...](#)

This year we will gather to celebrate the extraordinary achievements of five award winners' contributions to social justice and solidarity in Europe and around the world, including grassroot organisations working with migrants, an Asian trade union, indigenous peoples from South America and two academics who have developed a new approach to social justice. The award winners will take centre-stage at this new format conference-style event to highlight the crucial topics that they are working on to Brussels stakeholders.

International Cooperation

Social Justice in the Middle East and North Africa

Next week, from 24 to 26 September, SOLIDAR members and partners from the Middle East and North Africa will meet in Brussels to discuss an alternative socio-economic development paradigm for the region. Organised in cooperation with the [Global Progressive Forum](#) and the [Global Network](#), this [three day seminar](#) will bring together civil society organisations, think tanks, independent trade unions and progressive political forces from Algeria, Egypt, Jordan, Lebanon, Libya, Morocco, Palestine, Syria and Tunisia to debate strategies that are aimed at reducing poverty and tackling growing (social) inequalities in the region. Supporting Change in Transition Countries: Focus on Freedom of Association

Last week SOLIDAR had a meeting with Andris Gobins (member of the European Economic and Social Committee) on the [EU's support for sustainable change in transition countries](#), a Communication by the European Commission and High Representative of the European Union for Foreign Affairs and Security Policy. The Communication highlights that people in every part of the world aspire to political freedom, security, accountable government, economic opportunities and justice and it indicates that countries in the EU's own neighbourhood have recently embarked on major reforms designed to transform their societies into inclusive democracies that are both willing and able to address the needs and aspirations of the population.
