Middle East and North Africa: On the Way to Social Justice?

When the uprisings in the Middle East and North African (MENA) countries started three years ago, expectations and hopes were raised which were quickly confronted with the realities and difficulties inherent in transitions. Besides the political instabilities in Egypt, Libya and Tunisia, there is a strong need to find answers and develop solutions to tackle the growing inequalities, ensure human rights and fight poverty. That is why SOLIDAR has been working to build an alliance of progressive civil society, trade unions and progressive political forces from the very beginning, an alliance which met this week in a series of meetings in Brussels. Thematic newsletter: Social Justice in Middle East and North Africa

From Tuesday to Thursday (24-26 Sept), SOLIDAR members and partners from the Middle East and North Africa (MENA) met in Brussels to discuss an alternative socio-economic development paradigm for the region. Organised in cooperation with the [Global Progressive Forum](#) and the [Global Network](#), this [three day seminar](#) brought together civil society organisations, think tanks, independent trade unions and progressive political forces from the region to debate strategies aimed at reducing poverty and tackling growing (social) inequalities in the region.

A New Roadmap to Promote Freedom of Association, Decent Work and Social Protection

Last June, SOLIDAR published the first European Neighbourhood Policy Progress Report on [Freedom of Association in the Middle East in North Africa](#). This report highlights the worrying developments in Algeria, Egypt, Jordan, Lebanon, Morocco, Palestine and Tunisia of encroachments to the freedom of association and peaceful assembly, freedom of expression and information, and democratic transition and civil dialogue.

On Tuesday, members of the [Social Justice in the Middle East and North Africa \(MENA\) Network](#), coordinated by SOLIDAR in cooperation with its members, developed a roadmap that will strengthen our common efforts to jointly [advocate for freedom of peaceful assembly and association, promote social justice and advocate for more investment in social protection and decent work](#) in the region. New report: Investing in Decent Work and Social Protection in MENA

On Wednesday, at a seminar organised by SOLIDAR in cooperation with the [Global Progressive Forum](#) and the [Global Network](#), bringing together civil society organisations, think tanks, independent trade unions and progressive political forces from the Middle East and North Africa (MENA) with Members of the European Parliament Josef Weidenholzer (SOLIDAR President), Véronique De Keyser, Marc Tarabella, Bernd Lange and the European Union Special Representative for the Southern Mediterranean Bernardino Leon, SOLIDAR launched a [new report on decent work and social protection in the MENA region](#).

The report highlights the problems that the MENA region is facing today: mass unemployment throughout the whole region, especially among young people and women; structural problems of unskilled young people, as well as underemployment; rising poverty; rising informal employment; increasing child labour; lack of fundamental freedoms; and the heritage of (neoliberal) perspectives from former authoritarian regimes.
