Big Brother is Watching

On Wednesday, the European Parliament decided to suspend the SWIFT data exchange agreement with the US as a reaction to the scandal whereby the National Security Agency (NSA) was supervising all kinds of communications in the EU. Secret services from the US and the UK feel free to supervise private communication and data exchange under the pretext of preventing terrorist attacks. The British secret service has even monitored national Belgian telephone company, Belgacom, and could through this control communication within the EU institutions. International Cooperation

Freedom of Association, Decent Work and Social Justice: Preconditions for Sustainable Development

SOLIDAR welcomes the [opinion](#) of the European Economic and Social Committee (EESC) on the European Commission Communication which seeks to improve the EU's support to countries undergoing major political, social and economic reforms – so-called transition countries. This opinion states that in order to achieve sustainable development, support for democracy, freedom of association and peaceful assembly, civic education, non-formal and informal learning and social justice is essential.

The opinion, presented by Andris Gobiņš (EESC Group III, Latvia), underlines that support to neighbouring countries should not be perceived as a gain for only a selected few. Visible improvements are needed in fields such as public and social services, decent work and quality employment, gender equality, support for socially and economically vulnerable and indigenous peoples, etc. in order to foster change. This was one of the recommendations suggested by SOLIDAR through

the CONCORD working group on Enlargement, Pre-Accession and Neighbourhood. [Read more...](#)

Trade Union Action to Promote Migrant Rights in the Mediterranean Region

This week, on 21-22 October, at the International Training Center of the ILO, Italian SOLIDAR member CGIL co-organised together with the UGTT (Tunisia), a two day discussion on the role of trade unions in protecting migrant rights in the Mediterranean area. In the presence of representatives from ILO-ACTRAV (Bureau for Workers' Activities), the Friedrich-Ebert-Stiftung (FES), the European Commission, the ETUC and SOLIDAR, numerous delegations of trade unions from Europe and the Middle East and North Africa (MENA) region agreed to foster cooperation and to create a network to promote, defend, protect and give a voice to those hundreds of migrant workers that everyday leave their countries to look for a decent work for a decent life elsewhere (read the [seminar conclusions](#)).

Lifelong Learning

Fighting Youth Unemployment and Precarious Work

Last week, SOLIDAR brought together 15 young trade unionists at a conference in the European Parliament, hosted by MEP Emer Costello and attended by MEPs Emily Turunen, Elisabeth Schroedter and Marije Cornelissen, Vice-President of the Committee of Regions, Mercedes Bresso, as well as representatives from Eurofound and the European Youth Forum.

Based on discussions in the conference, SOLIDAR recommends that European policy initiatives - such as the Youth Employment Package that includes the Youth Guarantee - are strengthened to ensure that all young people are offered a job, apprenticeship, traineeship or continued education. And these initiatives must be based on decent work and quality employment. At the meeting a briefing paper was also launched by young trade unionists entitled: "[Decent work and quality jobs for young people – a collation of articles on the employment situation and working conditions of young people](#)". Raising Awareness on Rights at Work

[Youth Job Patrol](#), a project carried out by [Flaglit Internationalt Center](#) (FIC), [Ideas Institute](#), [CGIL FILCAMS](#) and SOLIDAR, has worked to raise awareness amongst young people on their rights at work and to promote that they to get more actively involved in demanding decent working conditions in their jobs. The mission of the Youth Job Patrol is to conduct visits to companies and to inform young workers and their employers of their labour market rights.
