Dare to think : Nature unbound - decoupling for conservation

A good Anthropocene demands that humans use their growing social, economic, and technological powers to make life better for people, stabilize the climate, and protect the natural world. These two ideals can no longer be reconciled. Natural systems will not, as a general rule, be protected or enhanced by the expansion of humankind's dependence upon them for sustenance and well-being. Intensifying many human activities — particularly farming, energy extraction, forestry, and settlement — so that they use less land and interfere less with the natural world is the key to decoupling human development from environmental impacts. These socioeconomic and technological processes are central to economic modernization and environmental protection. Together they allow people to mitigate climate change, to spare nature, and to alleviate global poverty.

This Ecomodernist view forces many academics to think about the limits of technological development and a sustainable use of our natural resources. Ted Nordhaus, Linus Blomqvist and a team of academics and progressive policy makers developed this vision as members of the Californian Breakthrough Institute. They will present their Ecomodernist manifest at Ghent University the 28th of September.

The activity is open for everybody, so also for non-UGent members.

► Nagoya Protocol on Access and Benefit Sharing (ABS) - Training workshop on 13th of October 2015

Are you familiar with the **Nagoya Protocol** and the EU ABS Regulation?



If **not**, then this news is of an interest to you, as it provides you with an opportunity to develop your knowledge of this important new legal framework, which is of relevance in the daily practice of every scientist working with genetic resources.

What's in it for you?

The **EU ABS Regulation training workshop** aims at providing the participants with knowledge about their obligations under the EU ABS Regulation and what they practically imply for their everyday work. In the first part of the workshop, the new legal framework will be explained, providing insight into the main provisions of the EU ABS Regulation. In the second part of the workshop, participants will have a chance to put the knowledge gained into practice through interactive case studies, based on real-life examples and realistic scenarios.

The training workshop will allow participants to better understand their obligations under the EU ABS Regulation, and to establish which steps they need to follow and which practical measures they should take when using genetic resources

originating from Parties to the **Nagoya Protocol** in the EU.

The training workshop is targeted at academics and scientists conducting research and development on genetic resources who have an interest in **gaining an essential understanding** of the new legal framework in the EU, in view of the EU ABS Regulation becoming fully operational later this year.

Please bear in mind that **these workshops are not intended to be meetings of ABS law and policy experts**, but rather to give a training on all key aspects of the EU ABS Regulation for researchers using genetic resources. No prior knowledge of ABS legislation is required or expected.

► Version 2.3 of the IPT now available

The IT team of the webportal www.gbif.org has published the new version of the Integrated Publishing Toolkit (IPT). Two major innovations are to be found :

1. The possibility to license and to attribute a DOI (Digital Object Identifier) to the datasets
2. This version 2.3 offers a new feature to publish sampling data (sample-based data).



IPT is a free open source software tool written in Java that is used to publish and share biodiversity datasets through the GBIF network. Designed for interoperability, it enables the publishing of content in databases, Microsoft Excel spreadsheets, or text files using open standards namely the Darwin Core and the Ecological Metadata Language. You can also use a 'one-click' service to convert your metadata into a draft data paper manuscript for submission to a peer-reviewed journal.
